A BILL TO BE ENTITLED AN ACT

relating to grounds for the involuntary termination of the parent-child relationship.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

Section 154.001(a-1), Family Code, is amended to SECTION 1. read as follows:

- (a-1) The court may order each person who is financially able and whose parental rights have been terminated with respect to a child in substitute care for whom the department has been appointed managing conservator, a child for a reason described by Section $\underline{161.001(b)(1)(S)(iv)}$ or $\underline{(b)(1)(T)}$ $\underline{[161.001(b)(1)(T)(iv)]}$ or (b)(1)(U), or a child who was conceived as a direct result of conduct that constitutes an offense under Section 21.02, 22.011, 22.021, or 25.02, Penal Code, to support the child in the manner specified by the order:
 - (1) until the earliest of:
 - the child's adoption; (A)
- (B) the child's 18th birthday or graduation from high school, whichever occurs later;
- (C) removal of the child's disabilities minority by court order, marriage, or other operation of law; or
- the child's death; or (D) (2) if the child is disabled as defined in this chapter, for an indefinite period.

SECTION 2. Section 161.001(b), Family Code, is amended to read as follows:

The court may order termination of the parent-child (b) relationship if the court finds by clear and convincing evidence:

that the parent has: (1)

- (A) voluntarily left the child alone or in the possession of another not the parent and expressed an intent not to return;
- (B) voluntarily left the child alone or in the possession of another not the parent without expressing an intent to return, without providing for the adequate support of the child, and remained away for a period of at least three months;
- (C) voluntarily left the child alone or in the possession of another without providing adequate support of the child and remained away for a period of at least six months;
