| 7 | CHAPTER 455. GOVERNOR'S TASK FORCE ON GOVERNANCE OF EARLY |
| 8 | CHILDHOOD EDUCATION AND CARE |
| 9 | Sec. 455.001. DEFINITION. In this chapter, "task force" |
| 10 | means the governor's task force on the governance of early |
| 11 | childhood education and care established under this chapter. |
| 12 | Sec. 455.002. ESTABLISHMENT. (a) The governor's task |
| 13 | force on the governance of early childhood education and care is |
| 14 | established to address the governance and operational challenges of |
| 15 | the early childhood education system in this state. |
| 16 | (b) The task force is administratively attached to the Texas |
| 17 | Education Agency. |
| 18 | Sec. 455.003. MEMBERS. (a) The task force shall include a |
| 19 | steering committee composed of the following members: |
| 20 | (1) the executive commissioner of the Health and Human |
| 21 | Services Commission; |
| 22 | (2) the commissioner of the Texas Education Agency; |
| 23 | (3) the chair of the Texas Workforce Commission; |
| 24 | (4) relevant division directors designated by the |

| 4 | (b) The task force is composed of the following members: |
| 5 | (1) one public school teacher certified to teach |
| 6 | prekindergarten; |
| 7 | (2) one certified teacher who is employed by a private |
| 8 | child-care facility or prekindergarten program; |
| 9 | (3) a representative from the Texas Head Start State |
| 10 | Collaboration Office appointed by the governor; |
| 11 | (4) a representative from the Department of State |
| 12 | Health Services appointed by the governor; |
| 13 | (5) two representatives from the Texas Early Learning |

| 25 | Sec. 455.004. POWERS AND DUTIES. (a) The task force shall: |
| 26 | (1) examine governance and operational challenges in |
| 27 | the early childhood education and care system, including federal |

1 and local child-care programs and regulations governing those 2 programs; 3 (2) with a focus on improving government efficiency, conduct a comprehensive review of the existing functions and 4 5 responsibilities of the Health and Human Services Commission, Texas Education Agency, and Texas Workforce Commission related to early 6 childhood education and care; and 7 8 (3) consider methods for a large-scale redesign of the administration of early childhood programs to improve efficiency, 9 10 service delivery, quality of care, and the efficient use of funding. 11 12 (b) The steering committee of the task force shall: (1) align goals and metrics of the Health and Human 13 14 Services Commission, Texas Education Agency, and Texas Workforce 15 Commission to measure progress, including aligning statewide data 16 systems; and 17 (2) require the Health and Human Services Commission, Texas Education Agency, and Texas Workforce Commission to complete 18 and submit to the task force periodic progress reports and 19 regularly refine statewide goals and strategic plans to ensure 20 alignment with evolving early childhood education and care needs. 21 22 (c) From money appropriated or otherwise available for the purpose, the Texas Education Agency shall pay the costs of data 23 24 system integration, research, and administration for the task 25 force. 26 Sec. 455.005. REPORT. Not later than December 1, 2026, the task force shall develop and submit to the legislature policy and 27

budget recommendations designed to improve early childhood education and care governance that will: (1) facilitate and improve early childhood education

3 (1) facilitate and improve early childhood education
4 and care participant engagement with state agencies; and

5 (2) lead to improved operational efficiency, 6 increased affordable child care capacity, and improved 7 <u>kindergarten readiness.</u>

8 <u>Sec. 455.006. EXPIRATION. The task force is abolished and</u> 9 this chapter expires September 1, 2027.

10 SECTION 2. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13 Act does not receive the vote necessary for immediate effect, this 14 Act takes effect September 1, 2025.
