4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subtitle D, Title 4, Government Code, is amended
6	by adding Chapter 455 to read as follows:
7	CHAPTER 455. GOVERNOR'S TASK FORCE ON GOVERNANCE OF EARLY
8	CHILDHOOD EDUCATION AND CARE
9	Sec. 455.001. DEFINITION. In this chapter, "task force"
10	means the governor's task force on the governance of early
11	childhood education and care established under this chapter.
12	Sec. 455.002. ESTABLISHMENT. (a) The governor's task
13	force on the governance of early childhood education and care is
14	established to address the governance and operational challenges of
15	the early childhood education system in this state.
16	(b) The task force is administratively attached to the Texas
17	Education Agency.
18	Sec. 455.003. MEMBERS. (a) The task force shall include a
19	steering committee composed of the following members:
20	(1) the executive commissioner of the Health and Human
21	Services Commission;
22	(2) the commissioner of the Texas Education Agency;
23	(3) the chair of the Texas Workforce Commission;
24	(4) relevant division directors designated by the

1	individuals described by Subdivisions (1), (2), and (3); and
2	(5) the Texas Education Agency's inter-agency deputy
3	director of early childhood support.
4	(b) The task force is composed of the following members:
5	(1) one public school teacher certified to teach
6	prekindergarten;
7	(2) one certified teacher who is employed by a private
8	child-care facility or prekindergarten program;
9	(3) a representative from the Texas Head Start State
10	Collaboration Office appointed by the governor;
11	(4) a representative from the Department of State
12	Health Services appointed by the governor;
13	(5) two representatives from the Texas Early Learning
14	Council designated by the steering committee described by
15	Subsection (a); and
16	(6) at least two but not more than five individuals
17	with knowledge of early childhood education and care or experience
18	as a direct operator of an early childhood education and care
19	program, including business and community leaders, representatives
20	of nonprofit organizations, and other relevant stakeholders,
21	appointed by the governor.
22	(c) The governor shall appoint the chair of the task force.
23	(d) Chapter 2110 does not apply to the size, composition, or
24	duration of the task force.
25	Sec. 455.004. POWERS AND DUTIES. (a) The task force shall:
26	(1) examine governance and operational challenges in
27	the early childhood education and care system, including federal

1	and local child-care programs and regulations governing those
2	programs;
3	(2) develop and recommend standards for high quality
4	prekindergarten programs, including programs under Subchapter E-1,
5	Chapter 29, Education Code;
6	(3) with a focus on improving government efficiency,
7	conduct a comprehensive review of the existing functions and
8	responsibilities of the Health and Human Services Commission, Texas
9	Education Agency, and Texas Workforce Commission related to early
10	childhood education and care; and
11	(4) consider methods for a large-scale redesign of the
12	administration of early childhood programs to improve efficiency,
13	service delivery, quality of care, and the efficient use of
14	funding.
15	(b) The steering committee of the task force shall:
16	(1) align goals and metrics of the Health and Human
17	Services Commission, Texas Education Agency, and Texas Workforce
18	Commission to measure progress, including aligning statewide data
19	systems; and
20	(2) require the Health and Human Services Commission,
21	Texas Education Agency, and Texas Workforce Commission to complete
22	and submit to the task force periodic progress reports and
23	regularly refine statewide goals and strategic plans to ensure
24	alignment with evolving early childhood education and care needs.
25	(c) From money appropriated or otherwise available for the
26	purpose, the Texas Education Agency shall pay the costs of data
27	system integration, research, and administration for the task

1 force.

Sec. 455.005. REPORT. Not later than December 1, 2026, the task force shall develop and submit to the legislature policy and budget recommendations designed to improve early childhood education and care governance that will:

6 (1) facilitate and improve early childhood education 7 and care participant engagement with state agencies; and

8 (2) lead to improved operational efficiency, 9 increased affordable child care capacity, and improved 10 kindergarten readiness.

Sec. 455.006. EXPIRATION. The task force is abolished and this chapter expires September 1, 2027.

13 SECTION 2. An entity to which Chapter 455, Government Code, 14 as added by this Act, applies is required to implement a provision 15 of this Act only if the legislature appropriates money specifically 16 for that purpose. If the legislature does not appropriate money 17 specifically for that purpose, an entity may, but is not required 18 to, implement a provision of this Act using other money available 19 for that purpose.

SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this Act does not receive the vote necessary for immediate effect, this Act takes effect September 1, 2025.
