- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter A, Chapter 87, Education Code, is
- 6 amended by adding Section 87.005 to read as follows:
- 7 Sec. 87.005. TARLETON STATE UNIVERSITY COLLEGE OF
- 8 OSTEOPATHIC MEDICINE. (a) In this section:
- 9 (1) "Board" means the board of regents of The Texas A&M
- 10 University System.

- 11 (2) "College" means the Tarleton State University
- 12 College of Osteopathic Medicine established under this section.
- 13 (3) "University" means Tarleton State University.
- 14 (b) The Tarleton State University College of Osteopathic
- 15 Medicine is a college of the university and is under the management
- 16 and control of the board with degrees offered under the name and
- 17 authority of the university.
- 18 <u>(c) The board may prescribe courses leading to customary</u>
- 19 degrees and may adopt policies for the operation, control, and
- 20 management of the college as necessary for conducting a college of

- 22 (d) A teaching hospital considered suitable by the board may
- 23 be provided by a public or private entity.
