A BILL TO BE ENTITLED

1	AN ACT
2	relating to creating the criminal offenses of transnational
3	repression and unauthorized enforcement of foreign law and to a
4	study and law enforcement training regarding transnational
5	repression.
6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
7	SECTION 1. Chapter 76, Penal Code, is amended by adding
8	Sections 76.045 and 76.046 to read as follows:
9	Sec. 76.045. TRANSNATIONAL REPRESSION. (a) In this
10	<pre>section:</pre>
11	(1) "Agent of a foreign government or foreign
12	terrorist organization" means a person acting on behalf of or
13	otherwise employed or controlled by a foreign government or foreign
14	terrorist organization.
15	(2) "Foreign terrorist organization" has the meaning
16	assigned by Section 71.01.
17	(3) "Protected conduct" means any speech or expressive
18	conduct protected by the First Amendment to the United States
19	Constitution or by Section 8, Article I, Texas Constitution.
20	(b) A person commits an offense if:
21	(1) the person commits or conspires to commit an
22	offense under:
23	(A) Section 22.01;

(B) Section 22.02;

1	(C) Section 42.07; or
2	(D) Section 42.072;
3	(2) the person commits or conspires to commit an
4	offense described by Subdivision (1) with the intent to:
5	(A) cause another person to act on behalf of a
6	foreign government or a foreign terrorist organization;
7	(B) cause another person to leave the United
8	States;
9	(C) discourage another person from engaging in
10	protected conduct; or
11	(D) retaliate against another person for
12	engaging in protected conduct; and
13	(3) the person commits or conspires to commit that
14	offense as an agent of a foreign government or foreign terrorist
15	organization.
16	(c) An offense under this section is one category higher
17	than the most serious offense listed in Subsection (b)(1) that was
18	<pre>committed or conspired to be committed, except that:</pre>
19	(1) if the most serious offense is a Class A
20	misdemeanor, the offense under this section is a Class A
21	misdemeanor with a minimum term of confinement of 180 days; and
22	(2) if the most serious offense is a felony of the
23	first degree, the offense under this section is a felony of the
24	first degree with a minimum term of confinement of 15 years.
25	Sec. 76.046. UNAUTHORIZED ENFORCEMENT OF FOREIGN LAW. (a)
26	In this section, "agent of a foreign government or foreign
27	terrorist organization" has the meaning assigned by Section 76.045.

- 1 (b) A person commits an offense if, as an agent of a foreign
- 2 government or foreign terrorist organization, the person, without
- 3 the approval of this state or the United States:
- 4 (1) prevents another person in this state from
- 5 violating the laws of a foreign government; or
- 6 (2) detects, investigates, monitors, or surveilles
- 7 <u>another person in this state for the purpose of preventing the other</u>
- 8 person from violating the laws of a foreign government.
- 9 <u>(c)</u> An offense under this section is a felony of the second
- 10 <u>degree</u>.
- 11 SECTION 2. Subchapter A, Chapter 411, Government Code, is
- 12 amended by adding Section 411.02098 to read as follows:
- 13 Sec. 411.02098. TRANSNATIONAL REPRESSION TRAINING PROGRAM.
- 14 (a) In this section:
- 15 (1) "Agent of a foreign government or foreign
- 16 terrorist organization" and "agent" mean a person acting on behalf
- 17 of or otherwise employed or controlled by a foreign government or
- 18 foreign terrorist organization.
- 19 (2) "Foreign terrorist organization" has the meaning
- 20 assigned by Section 71.01, Penal Code.
- 21 (3) "Peace officer" means an individual described by
- 22 Article 2A.001, Code of Criminal Procedure.
- 23 (4) "Transnational repression" means conduct
- 24 described by Section 76.045(b), Penal Code.
- 25 (b) The criminal investigations division of the department
- 26 shall develop a training program for peace officers regarding
- 27 transnational repression. The training program must:

1	(1) prepare peace officers to:
2	(A) identify transnational repression;
3	(B) develop practices for preventing, reporting,
4	and responding to transnational repression; and
5	(C) recognize communities targeted by
6	transnational repression and misinformation that may be
7	perpetuated by an agent of a foreign government or foreign
8	terrorist organization; and
9	(2) include information about foreign governments and
10	foreign terrorist organizations that are frequently involved in
11	transnational repression and the methods those governments and
12	organizations use.
13	(c) The criminal investigations division shall regularly
14	update the training under Subsection (b) to address emerging
15	threats and new transnational repression methods used by agents of
16	a foreign government or foreign terrorist organization.
17	SECTION 3. (a) The criminal investigations division of the
18	Department of Public Safety of the State of Texas, in collaboration
19	with the office of the governor, shall conduct a study on the threat
20	of transnational repression, as that conduct is described by
21	Section 76.045(b), Penal Code, as added by this Act. Not later than
22	March 1, 2026, the Department of Public Safety shall prepare and
23	submit to each member of the legislature a report on the conclusions
24	of the study and any recommendations for legislative or other
25	action to reduce the threat of transnational repression.
26	(b) This section expires April 1, 2026.
