4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 191, Health and Safety
6	Code, is amended by adding Section 191.00495 to read as follows:
7	Sec. 191.00495. BIRTH RECORD ISSUED TO HOMELESS INDIVIDUAL.
8	(a) In this section, "homeless individual":
9	(1) means an individual who:
10	(A) lacks a fixed, regular, and adequate
11	nighttime residence; or
12	(B) has a primary nighttime residence that is:
13	(i) a supervised publicly or privately
14	operated shelter designed to provide temporary living
15	accommodations, including welfare hotels, congregate shelters, and
16	transitional housing for the mentally ill;
17	(ii) an institution that provides a
18	temporary residence for individuals intended to be
19	institutionalized; or
20	(iii) a public or private place not
21	designed for, or ordinarily used as, a regular sleeping
22	accommodation for human beings; and
23	(2) does not include an individual who is imprisoned
24	or otherwise detained in a correctional facility

- 1 (b) On request of a homeless individual, the state
- 2 registrar, a local registrar, or a county clerk shall issue,
- 3 without fee, a certified copy of the individual's birth record to
- 4 the individual.
- 5 <u>(c)</u> The executive commissioner by rule shall:
- 6 (1) adopt a process to verify a person's status as a
- 7 <u>homeless individual; and</u>
- 8 (2) prescribe the documentation necessary for
- 9 issuance of a certified copy of a birth record to a homeless
- 10 individual whose status is verified through the process adopted
- 11 <u>under Subdivision (1).</u>
- 12 (d) Notwithstanding any other provision of state law, the
- 13 <u>department may not require a homeless individual to provide a</u>
- 14 physical address of the individual's residence to satisfy any
- 15 <u>requirement of this section.</u>
- SECTION 2. As soon as practicable after the effective date
- 17 of this Act, the executive commissioner of the Health and Human
- 18 Services Commission shall adopt the rules required by Section
- 19 191.00495, Health and Safety Code, as added by this Act.
- 20 SECTION 3. The changes in law made by this Act apply to an
- 21 application for a birth record submitted on or after the effective
- 22 date of this Act. An application for a birth record submitted before
- 23 the effective date of this Act is governed by the law in effect on
- 24 the date the application was submitted, and the former law is
- 25 continued in effect for that purpose.
- SECTION 4. This Act takes effect September 1, 2025.
