- 23 date of recording of an affidavit of lien under Section 53.052. The
- 24 priority of a lien claimed by a person entitled to a lien under

- 26 respect to other mechanic's liens is determined by the date of

- 1 $[\frac{53.021(c)}{,} (\frac{d}{,} or (e)]$ is not valid or enforceable against a
- 2 grantee or purchaser who acquires an interest in the real property
- 3 before the time of inception of the lien.
- 4 SECTION 5. The changes in law made by this Act apply only to
- 5 an original contract entered into on or after the effective date of
- 6 this Act. An original contract entered into before the effective
- 7 date of this Act is governed by the law as it existed immediately
- 8 before the effective date of this Act, and that law is continued in
- 9 effect for that purpose.
- 10 SECTION 6. This Act takes effect September 1, 2025.
