4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 48.005, Education Code, is amended to
6	read as follows:
7	Sec. 48.005. AVERAGE <u>ENROLLMENT</u> [DAILY ATTENDANCE]. (a)
8	In this chapter, average enrollment [daily attendance] is:
9	(1) the <u>average number of students enrolled in the</u>
10	school district during a school year [quotient of the sum of
11	attendance for each day of the minimum number of days of instruction
12	as described under Section 25.081(a) divided by the minimum number
13	of days of instruction;
14	[(2) for a district that operates under a flexible
15	year program under Section 29.0821, the quotient of the sum of
16	attendance for each actual day of instruction as permitted by
17	Section 29.0821(b)(1) divided by the number of actual days of
18	instruction as permitted by Section 29.0821(b)(1);
19	[(3) for a district that operates under a flexible
20	school day program under Section 29.0822, the average daily
21	attendance as calculated by the commissioner in accordance with
22	Sections 29.0822(d) and (d-1)]; or
23	(2) [(4)] for a district that operates a half-day
24	program or a full-day program under Section 29.153(c), one-half of

- 1 the average enrollment [daily attendance] calculated under
- 2 Subdivision (1).
- 3 (b) A school district that experiences a decline of two
- 4 percent or more in average enrollment [daily attendance] shall be
- 5 funded on the basis of:
- 6 (1) the actual average <u>enrollment</u> [<u>daily attendance</u>]
- 7 of the preceding school year, if the decline is the result of the
- 8 closing or reduction in personnel of a military base; or
- 9 (2) subject to Subsection (e), an average enrollment
- 10 [daily attendance] not to exceed 98 percent of the actual average
- 11 enrollment [daily attendance] of the preceding school year, if the
- 12 decline is not the result of the closing or reduction in personnel
- 13 of a military base.
- 14 (c) The commissioner shall adjust the average enrollment
- 15 [daily attendance] of a school district that has a significant
- 16 percentage of students who are migratory children as defined by 20
- 17 U.S.C. Section 6399.
- 18 (d) The commissioner may adjust the average enrollment
- 19 [daily attendance] of a school district in which a disaster, flood,
- 20 extreme weather condition, fuel curtailment, or other calamity has
- 21 a significant effect on the district's enrollment [attendance]. In
- 22 addition to providing the adjustment for the amount of
- 23 instructional days during the semester in which the calamity first
- 24 occurred, an adjustment under this section may only be provided
- 25 based on a particular calamity for an additional amount of
- 26 instructional days equivalent to one school year. The commissioner
- 27 may divide the adjustment between two consecutive school years.

- 1 (e) For each school year, the commissioner shall adjust the 2 average <u>enrollment</u> [daily attendance] of school districts that are 3 entitled to funding on the basis of an adjusted average enrollment
- 4 [daily attendance] under Subsection (b)(2) so that:
- (1) all districts are funded on the basis of the same percentage of the preceding year's actual average enrollment [daily attendance]; and
- 8 (2) the total cost to the state does not exceed the 9 amount specifically appropriated for that year for purposes of 10 Subsection (b)(2).
- 11 (f) An open-enrollment charter school is not entitled to 12 funding based on an adjustment under Subsection (b)(2).
- If a student may receive course credit toward the 13 14 student's high school academic requirements and toward 15 student's higher education academic requirements for a single course, including a course provided under Section 28.009 by a 16 17 public institution of higher education, the time during which the student attends the course shall be counted as part of the minimum 18 number of instructional hours required for a student to be 19 considered a full-time student in average enrollment [daily 20 attendance] for purposes of this section. 21
 - [(g-1) The commissioner shall adopt rules to calculate average daily attendance for students participating in a blended learning program in which classroom instruction is supplemented with applied workforce learning opportunities, including participation of students in internships, externships, and

- <u>Time</u> [Subject to rules adopted by the commissioner under 1 (h) Section 48.007(b), time] that a student participates in an 2 3 off-campus instructional program provided by an entity other than a school district or open-enrollment charter school and approved by 4 the commissioner in accordance with commissioner rule [under 5 Section 48.007(a)] shall be counted as part of the minimum number of 6 instructional hours required for a student to be considered a 7 8 full-time student in average enrollment [daily attendance] for purposes of this section. 9
- (i) A district or a charter school operating under Chapter
 11 12 that operates a prekindergarten program is eligible to receive
 12 one-half of average enrollment [daily attendance] under Subsection
 13 (a) if the district's or charter school's prekindergarten program
 14 provides at least 32,400 minutes of instructional time to students.
- (j) A district or charter school is eligible to earn full average <u>enrollment</u> [daily attendance] under Subsection (a) if the district or school provides at least 43,200 minutes of instructional time to students enrolled in:
- 19 (1) a dropout recovery school or program operating 20 under Section 12.1141(c) or Section 39.0548;
- 21 (2) an alternative education program operating under 22 Section 37.008;
- (3) a school program located at a day treatment facility, residential treatment facility, psychiatric hospital, or medical hospital;
- 26 (4) a school program offered at a correctional 27 facility; or

- 1 (5) a school operating under Subchapter G, Chapter 12.
- 2 (k) A charter school operating under a charter granted under
- 3 Chapter 12 before January 1, 2015, is eligible to earn full average
- 4 enrollment [daily attendance] under Subsection (a), as that
- 5 subsection existed immediately before January 1, 2015, for:
- 6 (1) all campuses of the charter school operating
- 7 before January 1, 2015; and
- 8 (2) any campus or site expansion approved on or after
- 9 January 1, 2015, provided that the charter school received an
- 10 academic accountability performance rating of C or higher, and the
- 11 campus or site expansion is approved by the commissioner.
- 12 (1) A school district campus or charter school described by
- 13 Subsection (j) may operate more than one program and be eligible for
- 14 full average enrollment [daily attendance] for each program if the
- 15 programs operated by the district campus or charter school satisfy
- 16 all applicable state and federal requirements.
- 17 (m) The commissioner shall adopt rules necessary to
- 18 implement this section, including rules that:
- 19 (1) <u>determine the method to calculate the average</u>
- 20 number of students enrolled in a school district during a school
- 21 <u>year;</u>
- 22 (2) establish the minimum amount of instructional time
- 23 per day that allows a school district or charter school to be
- 24 eligible for full average enrollment [daily attendance], which may
- 25 differ based on the instructional program offered by the district
- 26 or charter school;
- (3) $\left[\frac{(2)}{(2)}\right]$ establish the requirements necessary for a

- 5 (4) $\left[\frac{(3)}{(3)}\right]$ proportionally reduce the average
- 6 enrollment [daily attendance] for a school district if any campus
- 7 or instructional program in the district provides fewer than the
- 8 required minimum minutes of instruction to students; and
- 9 (5) $[\frac{(4)}{1}]$ allow a grade or course repeated under
- 10 Section 28.02124 to qualify for average enrollment [daily
- 11 attendance] even if the student previously passed or earned credit
- 12 for the grade or course, if the grade or course would otherwise be
- 13 eligible.
- 14 (n) To assist school districts in implementing this section
- 15 as amended by H.B. 2442, [Acts of the] 85th Legislature, Regular
- 16 Session, 2017, the commissioner may waive a requirement of this
- 17 section or adopt rules to implement this section.
- SECTION 2. Section 7.062(a), Education Code, is amended to
- 19 read as follows:
- 20 (a) In this section, "wealth per student" means a school
- 21 district's taxable value of property as determined under Subchapter
- 22 M, Chapter 403, Government Code, or, if applicable, Section 48.258,
- 23 divided by the district's average enrollment [daily attendance] as
- 24 determined under Section 48.005.
- SECTION 3. Section 11.052(f), Education Code, is amended to
- 26 read as follows:
- 27 (f) If single-member trustee districts are adopted or

- approved as provided by this section, the board shall divide the 1 school district into the appropriate number of trustee districts, 2 based on the number of members of the board that are to be elected from single-member trustee districts, and shall number each trustee 4 5 district. The trustee districts must be compact and contiguous and must be as nearly as practicable of equal population. In a district 6 with 150,000 or more students in average enrollment 7 8 attendance], the boundary of a trustee district may not cross a county election precinct boundary except at a point at which the 9 10 boundary of the school district crosses the county election precinct boundary. - 25 (a-2) In addition to the funding provided by Subsection (a), 26 a charter holder is entitled to receive for the open-enrollment 27 charter school an allotment per student in average <u>enrollment</u>

- SECTION 5. Sections 12.263(a), (b), and (c), Education
- 2 Code, are amended to read as follows:
- 3 (a) Except as otherwise provided by this section, funding
- 4 for an adult education program operated under a charter granted
- 5 under this subchapter is an amount per participant through the
- 6 Foundation School Program equal to the amount of state funding per
- 7 student in weighted average enrollment [daily attendance] that
- 8 would be allocated under the Foundation School Program for the
- 9 student's enrollment [attendance] at an open-enrollment charter
- 10 school in accordance with Section 12.106.
- 11 (b) For purposes of determining the average enrollment
- 12 [daily attendance] of an adult education program operated under a
- 13 charter granted under this subchapter, a student is considered to

- 6 SECTION 6. Section 13.051(c), Education Code, is amended to
- 7 read as follows:
- 8 (c) Territory that does not have residents may be detached
- 9 from a school district and annexed to another school district if:
- 10 (1) the total taxable value of the property in the
- 11 territory according to the most recent certified appraisal roll for
- 12 each school district is not greater than:
- 13 (A) five percent of the district's taxable value
- 14 of all property in that district as determined under Subchapter M,
- 15 Chapter 403, Government Code; and
- 16 (B) \$5,000 property value per student in average
- 17 enrollment [daily attendance] as determined under Section 48.005;
- 18 and
- 19 (2) the school district from which the property will
- 20 be detached does not own any real property located in the territory.
- 21 SECTION 7. Section 13.102, Education Code, is amended to
- 22 read as follows:
- Sec. 13.102. MINIMUM AREA AND <u>ENROLLMENT</u> [ATTENDANCE]
- 24 REQUIREMENTS. A new district may not be created with an area of
- 25 less than nine square miles or fewer than 8,000 students in average
- 26 enrollment [daily attendance], and a district may not be reduced to
- 27 an area of less than nine square miles or fewer than 8,000 students

- 1 in average enrollment [daily attendance].
- 2 SECTION 8. Section 13.283, Education Code, is amended to
- 3 read as follows:
- 4 Sec. 13.283. PAYMENTS REDUCED. The incentive aid payments
- 5 shall be reduced in direct proportion to any reduction in the
- 6 average enrollment [daily attendance] as determined under Section
- 7 48.005 of the reorganized school district for the preceding year.
- 8 SECTION 9. Section 19.009(d-2), Education Code, is amended
- 9 to read as follows:
- 10 (d-2) Beginning with the 2009-2010 school year, the
- 11 district shall increase the monthly salary of each classroom
- 12 teacher, full-time speech pathologist, full-time librarian,
- 13 full-time school counselor certified under Subchapter B, Chapter
- 14 21, and full-time school nurse employed by the district by the
- 15 greater of:
- 16 (1) \$80; or
- 17 (2) the maximum uniform amount that, when combined
- 18 with any resulting increases in the amount of contributions made by
- 19 the district for social security coverage for the specified
- 20 employees or by the district on behalf of the specified employees
- 21 under Section 825.405, Government Code, may be provided using an
- 22 amount equal to the product of \$60 multiplied by the number of
- 23 students in weighted average enrollment [daily attendance] in the
- 24 district during the 2009-2010 school year.
- 25 SECTION 10. Section 25.038, Education Code, is amended to
- 26 read as follows:
- 27 Sec. 25.038. TUITION FEE FOR TRANSFER STUDENTS. The

- 1 receiving school district may charge a tuition fee to the extent
- 2 that the district's actual expenditure per student in average
- 3 <u>enrollment</u> [daily attendance], as determined by its board of
- 4 trustees, exceeds the sum the district benefits from state aid
- 5 sources as provided by Section 25.037. However, unless a tuition
- 6 fee is prescribed and set out in a transfer agreement before its
- 7 execution by the parties, an increase in tuition charge may not be
- 8 made for the year of that transfer that exceeds the tuition charge,
- 9 if any, of the preceding school year.
- SECTION 11. Section 25.045(c), Education Code, is amended
- 11 to read as follows:
- 12 (c) A student who transfers to another school district under
- 13 this section may not be charged tuition. The student is included in
- 14 the average enrollment [daily attendance] of the district in which
- 15 the student attends school.
- SECTION 12. Sections 25.081(e) and (f), Education Code, are
- 17 amended to read as follows:
- 18 (e) A school district or education program is exempt from
- 19 the minimum minutes of operation requirement if the district's or
- 20 program's average <u>enrollment</u> [<u>daily attendance</u>] is calculated
- 21 under Section 48.005(j).
- 22 (f) The commissioner may proportionally reduce the amount
- 23 of funding a district receives under Chapter 46, 48, or 49 and the
- 24 average enrollment [daily attendance] calculation for the district
- 25 if the district operates on a calendar that provides fewer minutes
- 26 of operation than required under Subsection (a).
- 27 SECTION 13. Section 25.087(d), Education Code, is amended

- 1 to read as follows:
- 2 (d) A student whose absence is excused under Subsection (b),
- 3 (b-1), (b-2), (b-4), (b-5), (b-7), (b-8), or (c) may not be
- 4 penalized for that absence and shall be counted as if the student
- 5 attended school for purposes of funding under Chapter 48
- 6 [calculating the average daily attendance of students in the school
- 7 district]. A student whose absence is excused under Subsection (b),
- 8 (b-1), (b-2), (b-4), (b-5), (b-7), (b-8), or (c) shall be allowed a
- 9 reasonable time to make up school work missed on those days. If the
- 10 student satisfactorily completes the school work, the day of
- 11 absence shall be counted as a day of compulsory attendance.
- 12 SECTION 14. Section 25.111, Education Code, is amended to
- 13 read as follows:
- 14 Sec. 25.111. STUDENT/TEACHER RATIOS. Except as provided by
- 15 Section 25.112, each school district must employ a sufficient
- 16 number of teachers certified under Subchapter B, Chapter 21, to
- 17 maintain an average ratio of not less than one teacher for each 20
- 18 students in average enrollment [daily attendance].
- 19 SECTION 15. Sections 25.112(a) and (b), Education Code, are
- 20 amended to read as follows:
- 21 (a) Except as otherwise authorized by this section, a school
- 22 district may not enroll more than 22 students in a prekindergarten,
- 23 kindergarten, first, second, third, or fourth grade class. That
- 24 limitation does not apply during:
- 25 (1) any 12-week period of the school year selected by
- 26 the district, in the case of a district whose average enrollment
- 27 [daily attendance] is adjusted under Section 48.005(c); or

- 1 (2) the last 12 weeks of any school year in the case of 2 any other district.
- 3 (b) Not later than the 30th day after the first day of the 4 12-week period for which a district whose average enrollment [daily attendance] is adjusted under Section 48.005(c) is claiming an exemption under Subsection (a), the district shall notify the commissioner in writing that the district is claiming an exemption 8 for the period stated in the notice.
- 9 SECTION 16. Section 29.008(b), Education Code, is amended 10 to read as follows:
- Except as provided by Subsection (c), costs of an 11 approved contract for residential placement may be paid from a 12 combination of federal, state, and local funds. The local share of 13 14 the total contract cost for each student is that portion of the 15 local tax effort that exceeds the district's local fund assignment under Section 48.256, divided by the average enrollment [daily 16 17 attendance] in the district. If the contract involves a private facility, the state share of the total contract cost is that amount 18 remaining after subtracting the local share. 19 If the contract involves a public facility, the state share is that amount 20 remaining after subtracting the local share from the portion of the 21 22 contract that involves the costs of instructional and related For purposes of this subsection, "local tax effort" 23 services. 24 means the total amount of money generated by taxes imposed for debt service and maintenance and operation less any amounts paid into a 25 26 tax increment fund under Chapter 311, Tax Code.
- 27 SECTION 17. Section 29.014(b), Education Code, is amended

- 1 to read as follows:
- 2 (b) A school district to which this section applies may
- 3 operate an extended year program for a period not to exceed 45 days.
- 4 [The district's average daily attendance shall be computed for the
- 5 regular school year plus the extended year.
- 6 SECTION 18. Section 29.081(f), Education Code, is amended
- 7 to read as follows:
- 8 (f) The commissioner shall include a student who
- 9 successfully completes a course offered through a program under
- 10 Subsection (e) in the computation of the district's or school's
- 11 average enrollment [daily attendance] for funding purposes. [For a
- 12 student who successfully completes a remote course offered through
- 13 the program, the commissioner shall include the student in the
- 14 computation of the district's or school's average daily attendance
- 15 with an attendance rate equal to:
- 16 [(1) the district's or school's average attendance
- 17 rate for students successfully completing a course offered in
- 18 person under the program; or
- 19 [(2) if the district or school does not offer courses
- 20 in person under the program, the statewide average attendance rate
- 21 for students successfully completing a course offered in person
- 22 under a program under Subsection (e).
- SECTION 19. Section 29.0822(d), Education Code, is amended
- 24 to read as follows:
- 25 (d) The commissioner may adopt rules for the administration
- 26 of this section, including rules establishing application
- 27 requirements. [Subject to Subsection (d-1), the commissioner shall

- 1 calculate average daily attendance for students served under this section. The commissioner shall allow accumulations of hours of 2 instruction for students whose schedule would not otherwise allow full state funding. Funding under this subsection shall be 4 5 determined based on the number of instructional days in the school district calendar and a seven-hour school day, but attendance may 6 be cumulated over a school year, including any summer or vacation 7 session. The attendance of students who accumulate less than the number of attendance hours required under this subsection shall be 9 10 proportionately reduced for funding purposes. The commissioner may: 11
- [(1) set maximum funding amounts for an individual
 course under this section; and
- [(2) limit funding for the attendance of a student described by Subsection (a)(3) in a course under this section to funding only for the attendance necessary for the student to earn class credit that, as a result of attendance requirements under Section 25.092, the student would not otherwise be able to receive without retaking the class.]
- 20 SECTION 20. Section 29.184(b), Education Code, is amended 21 to read as follows:
- (b) A student who attends career and technology classes at another school under a contract authorized by Subsection (a) is included in the average <u>enrollment</u> [daily attendance] of the district in which the student is regularly enrolled.
- SECTION 21. Sections 29.203(a) and (c), Education Code, are amended to read as follows:

- 1 (a) A student who under this subchapter uses a public
- 2 education grant to attend a public school in a school district other
- 3 than the district in which the student resides is included in the
- 4 average enrollment [daily attendance] of the district in which the
- 5 student attends school.
- 6 (c) A school district is entitled to additional facilities
- 7 assistance under Section 48.301 if the district agrees to:
- 8 (1) accept a number of students using public education
- 9 grants that is at least one percent of the district's average
- 10 <u>enrollment</u> [daily attendance] for the preceding school year; and
- 11 (2) provide services to each student until the student
- 12 either voluntarily decides to attend a school in a different
- 13 district or graduates from high school.
- 14 SECTION 22. Section 29.403(b), Education Code, is amended
- 15 to read as follows:
- 16 (b) A student who is enrolled in a program under this
- 17 subchapter is included in determining the average enrollment [daily
- 18 attendance] under Section 48.005 of the partnering school district.
- 19 SECTION 23. Section 29.457(a), Education Code, is amended
- 20 to read as follows:
- 21 (a) In addition to other funding to which a school district
- 22 is entitled under this code, each district in which alleged
- 23 offender residents attend school is entitled to an annual allotment
- 24 of \$5,100 for each resident in average enrollment [daily
- 25 attendance] or a different amount for any year provided by
- 26 appropriation.
- 27 SECTION 24. Section 29.912(c), Education Code, is amended

- 1 to read as follows:
- 2 (c) The program must enable an eligible school district that
- 3 has fewer than 1,600 students in average enrollment [daily
- 4 attendance] to partner with at least one other school district
- 5 located within a distance of 100 miles to offer a broader array of
- 6 robust college and career pathways. Each partnership must:
- 7 (1) offer college and career pathways that align with
- 8 regional labor market projections for high-wage, high-demand
- 9 careers; and
- 10 (2) be managed by a coordinating entity that:
- 11 (A) has or will have at the time students are
- 12 served under the partnership the capacity to effectively coordinate
- 13 the partnership;
- 14 (B) has entered into a performance agreement
- 15 approved by the board of trustees of each partnering school
- 16 district that confers on the coordinating entity the same authority
- 17 with respect to pathways offered under the partnership provided to
- 18 an entity that contracts to operate a district campus under Section
- 19 11.174;
- 20 (C) is an eligible entity as defined by Section
- 21 12.101(a); and
- (D) has on the entity's governing board as either
- 23 voting or ex officio members, or has on an advisory body,
- 24 representatives of each partnering school district and members of
- 25 regional higher education and workforce organizations.
- SECTION 25. Section 30.003(b), Education Code, is amended
- 27 to read as follows:

- (b) If the student is admitted to the school for a full-time program for the equivalent of two long semesters, the district's share of the cost is an amount equal to the dollar amount of maintenance and debt service taxes imposed by the district for that year divided by the district's average enrollment [daily attendance] for the preceding year.
- 7 SECTION 26. Section 30.102(a), Education Code, is amended 8 to read as follows:
