(c) Money in the gulf coast protection account may be used 15 16 only to pay for expenditures that: (1) are necessary to fulfill nonfederal sponsor 17 obligations under agreements with the United States Army Corps of 18 Engineers for implementing projects included in the plan 19 recommended by the Coastal Texas Protection and Restoration 20 21 Feasibility Study Final Report and Final Environmental Impact Statement dated August 2021 issued by the Galveston District, 22 23 Southwestern Division, of the United States Army Corps of Engineers 24 and the land office;

- 2 agreement executed by the land office and the Gulf Coast Protection
- 3 <u>District established under Chapter 9502</u>, <u>Special District Local</u>

- 7 the portion of the gulf coast located within the territory of the
- 8 district; or
- 9 (B) would benefit the district and are designated
- 10 <u>as Coastal Storm Risk Management Projects within the Coastal Texas</u>

- 12 (d) The legislature finds that the expenditure of money in
- 13 the gulf coast protection account in accordance with Subsection (c)
- 14 serves a public purpose.
- 15 (e) The expenditure of money in the gulf coast protection
- 16 account is subject to audit by the state auditor.
- 17 SECTION 2. This Act takes effect immediately if it receives
- 18 a vote of two-thirds of all the members elected to each house, as
- 19 provided by Section 39, Article III, Texas Constitution. If this
- 20 Act does not receive the vote necessary for immediate effect, this
- 21 Act takes effect September 1, 2025.
