## A BILL TO BE ENTITLED

1	AN ACT

- 2 relating to the exemption of tuition and laboratory fees at public
- 3 institutions of higher education for certain paramedics.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Subchapter D, Chapter 54, Education Code, is
- 6 amended by adding Section 54.3532 to read as follows:
- 7 Sec. 54.3532. PARAMEDICS ENROLLED IN CERTAIN COURSES. (a)
- 8 The governing board of an institution of higher education shall
- 9 exempt from the payment of tuition and laboratory fees any student
- 10 enrolled in one or more courses offered as part of an emergency
- 11 medical services curriculum who is employed as a paramedic by a
- 12 political subdivision of this state.
- (b) An exemption provided under this section does not apply
- 14 to deposits that may be required in the nature of security for the
- 15 return or proper care of property loaned for the use of students.
- 16 (c) Notwithstanding Subsection (a), a student who for a
- 17 semester or term at an institution of higher education receives an
- 18 <u>exemption provided under this section may continue to receive the</u>
- 19 <u>exemption for a subsequent semester or term at any institution only</u>
- 20 <u>if the student makes satisfactory academic progress toward a degree</u>
- 21 or certificate at that institution as determined by the institution
- 22 for purposes of financial aid.
- 23 (d) Notwithstanding Subsection (a), the exemption provided
- 24 under this section does not apply to any amount of additional

- 1 tuition the institution elects to charge a resident undergraduate
- 2 student under Section 54.014(a) or (f).
- 3 (e) Notwithstanding Subsection (a), the exemption provided
- 4 under this section does not apply to any amount of tuition the
- 5 institution charges a graduate student in excess of the amount of
- 6 tuition charged to similarly situated graduate students because the
- 7 <u>student has a number of semester credit hours of doctoral work in</u>
- 8 excess of the applicable number provided by Section 61.059(1)(1) or
- 9 (2).
- 10 (f) Notwithstanding Subsection (a), the governing board of
- 11 an institution of higher education is not required to provide an
- 12 exemption under this section for a course offered exclusively
- 13 through distance education to a number of students enrolled in the
- 14 course in excess of 20 percent of the maximum student enrollment
- 15 <u>designated by the institution for that course.</u>
- 16 (g) The Texas Higher Education Coordinating Board shall
- 17 adopt:
- 18 (1) rules governing the granting or denial of an
- 19 exemption provided under this section, including rules:
- 20 (A) prescribing the educational attainment or
- 21 level of certification necessary to qualify for an exemption as a
- 22 paramedic;
- 23 <u>(B) relating to the determination of a student's</u>
- 24 eligibility for an exemption; and
- 25 (C) relating to the exclusion from the exemption
- 26 under Subsection (f) of a distance education course, including
- 27 prescribing the maximum number of distance education courses that

- 1 may be excluded from the exemption under that subsection; and
- 2 (2) a uniform listing of degree programs covered by
- 3 the exemption provided under this section.
- 4 SECTION 2. (a) The Texas Higher Education Coordinating
- 5 Board shall adopt the rules required by Section 54.3532, Education
- 6 Code, as added by this Act, as soon as practicable after the
- 7 effective date of this Act.
- 8 (b) Section 54.3532, Education Code, as added by this Act,
- 9 applies beginning with tuition and laboratory fees charged for the
- 10 2025 fall semester. Tuition and laboratory fees charged for an
- 11 academic period before that semester are governed by the law in
- 12 effect immediately before the effective date of this Act, and the
- 13 former law is continued in effect for that purpose.
- 14 SECTION 3. This Act takes effect immediately if it receives
- 15 a vote of two-thirds of all the members elected to each house, as
- 16 provided by Section 39, Article III, Texas Constitution. If this
- 17 Act does not receive the vote necessary for immediate effect, this
- 18 Act takes effect September 1, 2025.
