8 DISTRIBUTION OF FUNDS FOR COUNSELING PROGRAMS. (a) In this

9 section, "school counselor" means a school counselor certified

10 under Subchapter B, Chapter 21.

11 (a-1) From funds appropriated for the purpose or other funds

that may be used for the purpose, the commissioner shall distribute

funds for programs under this subchapter. In distributing those

funds, the commissioner shall give preference to [a school district

17 of students at risk of dropping out of school, as described by

- 15 required by Section 33.002.
- SECTION 3. This Act applies beginning with the 2025-2026
- 17 school year.
- 18 SECTION 4. This Act takes effect immediately if it receives
- 19 a vote of two-thirds of all the members elected to each house, as
- 20 provided by Section 39, Article III, Texas Constitution. If this
- 21 Act does not receive the vote necessary for immediate effect, this
- 22 Act takes effect September 1, 2025.
