SECTION 5. The changes in law made by this Act apply to a claim for benefits or compensation pending on or filed on or after the effective date of this Act. A claim for benefits or compensation filed before that date, other than a claim pending on that date, is governed by the law in effect on the date the claim was made, and the former law is continued in effect for that purpose.

8 SECTION 6. This Act takes effect September 1, 2025.
