- 7 "You may consider the existence of the parole law. You are
- 8 not to consider the manner in which the parole law may be applied to
- 9 this particular defendant."
- 10 (b) In the penalty phase of the trial of a felony case in
- 11 which the punishment is to be assessed by the jury rather than the
- 12 court, if the offense is punishable as a felony of the first degree,
- 13 if a prior conviction has been alleged for enhancement of

- 10 conduct time earned equals one-fourth of the sentence imposed or 15
- 11 years, whichever is less. Eligibility for parole does not
- 12 guarantee that parole will be granted.
- "It cannot accurately be predicted how the parole law and
- 14 good conduct time might be applied to this defendant if sentenced to
- 15 a term of imprisonment, because the application of these laws will
- 16 depend on decisions made by prison and parole authorities.
- "You may consider the existence of the parole law and good
- 18 conduct time. However, you are not to consider the extent to which
- 19 good conduct time may be awarded to or forfeited by this particular
- 20 defendant. You are not to consider the manner in which the parole
- 21 law may be applied to this particular defendant."
