## A BILL TO BE ENTITLED

1 AN ACT 2 relating to the armed security officers required to be present at public schools and the appointment of reserve police officers by a 3 school district police department. 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 5 SECTION 1. Article 2A.001, Code of Criminal Procedure, is 6 7 amended to conform to Section 2, Chapter 624 (H.B. 4372), Section 1, Chapter 870 (H.B. 3981), Section 1, Chapter 950 (S.B. 1727), and 8

- 9 Section 1, Chapter 984 (S.B. 2612), Acts of the 88th Legislature,
- 10 Regular Session, 2023, and is further amended to read as follows:
- 11 Art. 2A.001. PEACE OFFICERS GENERALLY. The following are
- 12 peace officers:
- 13 (1) a sheriff, a sheriff's deputy, or a reserve deputy
- 14 sheriff who holds a permanent peace officer license issued under

- 16 (2) a constable, a deputy constable, or a reserve

- 9 SECTION 2. Section 37.0814(b), Education Code, is amended
- 10 to read as follows:
- 11 (b) A security officer described by Subsection (a) must be:
- 12 (1) a school district peace officer;
- 13 (2) a school resource officer; [or]
- 14 (3) a commissioned peace officer employed as security
- 15 personnel under Section 37.081;
- 16 (4) a reserve deputy sheriff appointed under Section
- 17 85.004, Local Government Code, who is a peace officer as described
- 18 by Article 2A.001, Code of Criminal Procedure;
- 19 (5) a reserve police officer appointed under Section
- 20 37.0816 who is a peace officer as described by Article 2A.001, Code
- 21 of Criminal Procedure; or
- 22 (6) an honorably retired peace officer, as that term
- 23 <u>is defined by Section 614.121, Government Code, who has:</u>
- 24 (A) kept their commission as a peace officer in
- 25 active status; and
- 26 (B) fulfilled all applicable requirements under
- 27 Sections 1701.351, 1701.3525, and 1701.357, Occupations Code.

- 1 SECTION 3. Subchapter C, Chapter 37, Education Code, is
- 2 amended by adding Section 37.0816 to read as follows:
- 3 Sec. 37.0816. RESERVE POLICE OFFICERS. (a) The board of
- 4 trustees of a school district may authorize the chief of police of
- 5 the school district police department to appoint reserve police
- 6 officers for the district. The board may limit the number of
- 7 reserve police officers that the chief may appoint.
- 8 (b) A reserve police officer serves at the discretion of the
- 9 chief of police of the school district police department and may be
- 10 called into service at any time that the chief considers it
- 11 necessary to have additional officers to preserve the peace and
- 12 enforce the law.
- 13 <u>(c) The chief of police of a school district police</u>
- 14 department may authorize a reserve police officer who holds a
- 15 permanent peace officer license issued under Chapter 1701,
- 16 Occupations Code, to carry a weapon or act as a peace officer at all
- 17 times, regardless of whether the reserve police officer is engaged
- 18 in the actual discharge of official duties, or may limit the
- 19 authority of the reserve police officer to carry a weapon or act as
- 20 a peace officer to only those times during which the reserve police
- 21 officer is engaged in the actual discharge of official duties.
- 22 <u>(d) A reserve police officer who does not hold a permanent</u>
- 23 peace officer license issued under Chapter 1701, Occupations Code,
- 24 may act as a peace officer only:
- 25 <u>(1) if the officer has fulfilled all applicable</u>
- 26 requirements under Sections 1701.351 and 1701.3525, Occupations
- 27 Code; and

- 1 (2) during the actual discharge of official duties.
- 2 (e) A reserve police officer on active duty at the call of
- 3 the chief of police of the school district police department and
- 4 actively engaged in assigned duties has the same rights,
- 5 privileges, and duties as any other peace officer of the state.
- 6 (f) A reserve police officer, regardless of whether the
- 7 reserve police officer holds a permanent peace officer license
- 8 <u>issued under Chapter 1701, Occupations Code, is not:</u>
- 9 (1) eligible for participation in any program provided
- 10 by the agency or the board of trustees of the school district that
- 11 is normally considered a financial benefit of full-time employment
- 12 or for any pension fund created by statute for the benefit of
- 13 full-time paid peace officers; or
- 14 (2) exempt from Chapter 1702, Occupations Code.
- SECTION 4. Section 1701.001(6), Occupations Code, is
- 16 amended to read as follows:
- 17 (6) "Reserve law enforcement officer" means a person
- 18 designated as a reserve law enforcement officer under Section
- 19 37.0816, Education Code, Section 85.004, 86.012, or 341.012, Local
- 20 Government Code, or Section 60.0775, Water Code.
- 21 SECTION 5. To the extent of any conflict, this Act prevails
- 22 over another Act of the 89th Legislature, Regular Session, 2025,
- 23 relating to nonsubstantive additions to and corrections in enacted
- 24 codes.
- 25 SECTION 6. This Act takes effect September 1, 2025.
