A BILL TO BE ENTITLED AN ACT

relating to the armed security officers required to be present at 1-21 public schools and the appointment of reserve police officers by a 1-22 1**-**23 school district police department. 1-24

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
