- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 6 SECTION 1. The heading to Section 370.007, Local Government
- 7 Code, as added by Chapter 1049 (S.B. 252), Acts of the 88th
- 8 Legislature, Regular Session, 2023, is amended to read as follows:
- 9 Sec. 370.007. APPOINTING OR EMPLOYING CERTAIN LEGAL
- 10 PERMANENT RESIDENTS [VETERANS] TO POSITION REQUIRING LICENSURE.
- 11 SECTION 2. Section 370.007(b), Local Government Code, as
- 12 added by Chapter 1049 (S.B. 252), Acts of the 88th Legislature,
- 13 Regular Session, 2023, is amended to read as follows:
- 14 (b) Notwithstanding any other law, a political subdivision
- 15 that appoints or employs a person to hold a position that requires
- 16 the person to be licensed by the commission may:
- 17 (1) appoint or employ a legal permanent resident of
- 18 the United States to be a county jailer if the person holds a county
- 19 jailer license issued by the commission; and
- 20 <u>(2)</u> appoint or employ a legal permanent resident of
- 21 the United States to hold <u>a</u> [the] position other than as a county
- 22 jailer if the person is an honorably discharged veteran of the armed
- 23 forces of the United States with at least two years of service
- 24 before discharge and holds the appropriate license issued by the

- 2 SECTION 3. Section 1701.3095, Occupations Code, is amended
- 3 to read as follows:
- 4 Sec. 1701.3095. LICENSING OF CERTAIN [VETERANS WHO ARE]
- 5 LEGAL PERMANENT RESIDENTS. (a) The commission shall issue a
- 6 license the commission is authorized to issue to a person who is a
- 7 legal permanent resident of the United States if the person:
- 8 (1) meets the requirements of this chapter and the
- 9 commission's rules for the license;
- 10 (2) is an honorably discharged veteran of the armed
- 11 forces of the United States with at least two years of service
- 12 before discharge; and
- 13 (3) presents evidence satisfactory to the commission
- 14 that the person has applied for United States citizenship.
- (b) Notwithstanding Subsection (a), the commission shall
- 16 <u>issue a county jailer license to a person who:</u>
- 17 (1) is a legal permanent resident of the United
- 18 States; and
- 19 (2) meets the requirements of this chapter and the
- 20 commission's rules for the license.
- 21 SECTION 4. Section 1701.451(a), Occupations Code, is
- 22 amended to read as follows:
- 23 (a) Before a law enforcement agency may hire a person
- 24 licensed under this chapter, the agency must, on a form and in the
- 25 manner prescribed by the commission:
- 26 (1) obtain the person's written consent for the agency
- 27 to review the information required to be reviewed under this

- 23 minimum qualifications for enrollment in a training program under
- 24 Section 1701.251(a);
- 25 (v) a military veteran's United States
- 26 Department of Defense Form DD-214 or other military discharge

- 3 SECTION 6. Section 1701.451(a), Occupations Code, as
- 4 amended by this Act, applies only to the hiring of a person by a law
- 5 enforcement agency that occurs on or after December 1, 2025. The
- 6 hiring of a person by a law enforcement agency that occurs before
- 7 that date is governed by the law in effect immediately before the
- 8 effective date of this Act, and the former law is continued in
- 9 effect for that purpose.
- 10 SECTION 7. This Act takes effect September 1, 2025.
