H.B. No. 1643

A BILL TO BE ENTITLED

1 AN ACT
2 relating to the authority of the Harris-Galveston Subsidence
3 District over the North Harris County Regional Water Authority.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

5 SECTION 1. Section 8801.005, Special District Local Laws
6 Code, is amended to read as follows:

7 Sec. 8801.005. DISTRICT TERRITORY. The district includes
8 the territory located within the boundaries of Harris County and
9 Galveston County, as that territory may have been modified under[+
10 ~~[(1) Section 8801.006 or its predecessor statute,~~
11 ~~former Section 151.003(b), Water Code, or~~
12 ~~[(2)]~~ other law.

13 SECTION 2. Subchapter A, Chapter 8801, Special District
14 Local Laws Code, is amended by adding Section 8801.007 to read as
15 follows:

16 Sec. 8801.007. APPLICABILITY TO CERTAIN TERRITORY.
17 Notwithstanding any other law, this chapter does not apply to:
18 (1) the North Harris County Regional Water Authority;
19 or
20 (2) property located in the territory of the North
21 Harris County Regional Water Authority, as described by Subchapter
22 B, Chapter 8888.

23 SECTION 3. Section 8888.001(7), Special District Local Laws
24 Code, is amended to read as follows:

1 (7) "Groundwater reduction plan" means a plan adopted
2 or implemented to supply water, reduce reliance on groundwater,
3 regulate groundwater pumping and water usage, or require and
4 allocate water usage among persons [~~in order to comply with or~~
5 ~~exceed the minimum requirements imposed by the subsidence~~
6 ~~district~~], including any applicable groundwater reduction
7 requirements.

8 SECTION 4. Section 8888.005(c), Special District Local Laws
9 Code, is amended to read as follows:

10 (c) The following laws do not apply to the authority:

- 11 (1) Chapter 8801 of this code;
12 (2) Chapter 36, Water Code;
13 (3) [~~(2)~~] Section 49.052, Water Code; and
14 (4) [~~(3)~~] Sections 49.451-49.455, Water Code.

15 SECTION 5. Section 8888.156(b), Special District Local Laws
16 Code, is amended to read as follows:

17 (b) [~~The board by rule shall exempt from the fee established~~
18 ~~under Subsection (a) each class of wells that is not subject to a~~
19 ~~groundwater reduction requirement imposed by the subsidence~~
20 ~~district. If an exempted class of wells becomes subject to a~~
21 ~~groundwater reduction requirement imposed by the subsidence~~
22 ~~district, the authority may charge the fee established under~~
23 ~~Subsection (a) on the wells of that class.] The board by rule may
24 exempt any [~~other~~] class of wells from the fee established under
25 Subsection (a).~~

26 SECTION 6. Section 8888.157(b), Special District Local Laws
27 Code, is amended to read as follows:

1 (b) The groundwater reduction plan may be amended at the
2 discretion of the authority [~~subject to the requirements and~~
3 ~~procedures of the subsidence district applicable to the amendment~~
4 ~~of groundwater reduction plans~~].

5 SECTION 7. Section 8888.165(a), Special District Local Laws
6 Code, is amended to read as follows:

7 (a) In implementing this chapter, the board may cooperate
8 with and request the assistance of the Texas Water Development
9 Board, the commission, the United States Geological Survey, the
10 Harris-Galveston Subsidence District [~~subsidence district~~], other
11 local governments, and other agencies of the United States and this
12 state.

13 SECTION 8. Section 8888.166(b), Special District Local Laws
14 Code, is amended to read as follows:

15 (b) The authority may expedite the financing and
16 construction of a surface water delivery system, or other projects
17 of the authority, to accomplish a conversion from reliance on
18 groundwater to reliance on surface water not later than [~~the~~
19 ~~earlier of:~~

20 [~~(1) the date required by the subsidence district, or~~
21 [~~(2)~~] the date determined by the board to be in the
22 interest of the authority or one or more districts inside or outside
23 the authority.

24 SECTION 9. The following provisions of the Special District
25 Local Laws Code are repealed:

26 (1) Section 8888.001(12);

27 (2) Section 8888.005(b);

- 1 (3) Section 8888.156(c);
- 2 (4) Section 8888.157(c);
- 3 (5) Section 8888.165(b); and
- 4 (6) Section 8888.201.

5 SECTION 10. This Act takes effect September 1, 2025.
