## A BILL TO BE ENTITLED

1 AN ACT

2 relating to the provision of counseling services by certain

- 3 providers under Medicaid and reimbursement for those services.
- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 32.027, Human Resources Code, is amended
- 6 by amending Subsection (1) and adding Subsection (m) to read as
- 7 follows:
- 8 (1) Subject to appropriations, the commission shall assure
- 9 that a recipient of medical assistance under this chapter may
- 10 select a licensed psychologist, a licensed marriage and family
- 11 therapist, as defined by Section 502.002, Occupations Code, a
- 12 licensed professional counselor, as defined by Section 503.002,
- 13 Occupations Code, or a licensed clinical [master] social worker, as
- 14 defined by Section 505.002, Occupations Code, to perform any health
- 15 care service or procedure covered under the medical assistance
- 16 program if the selected person is authorized by law to perform the
- 17 service or procedure. This subsection shall be liberally
- 18 construed.
- 19 (m) The commission shall assure that a recipient of medical
- 20 assistance under this chapter may select the following to perform
- 21 any health care service or procedure covered under the medical
- 22 <u>assistance program, including a service or procedure performed at a</u>
- 23 federally qualified health center as defined by 42 U.S.C. Section
- 24 1396d(1)(2)(B), if the selected person is licensed and authorized

- 1 by law to perform the service or procedure:
- 2 (1) a licensed marriage and family therapist
- 3 associate, as defined by Section 502.002, Occupations Code, who is
- 4 working toward fulfilling the supervised practice requirements to
- 5 be licensed as a licensed marriage and family therapist, as defined
- 6 by that section;
- 7 (2) a licensed master social worker, as defined by
- 8 Section 505.002, Occupations Code, who is actively pursuing the
- 9 education and training required to be licensed as a licensed
- 10 clinical social worker, as defined by that section; or
- 11 (3) a licensed professional counselor associate, as
- 12 described by 22 T.A.C. Chapter 681, who is working toward
- 13 fulfilling the supervised practice requirements to be licensed as a
- 14 licensed professional counselor, as defined by Section 503.002,
- 15 Occupations Code.
- SECTION 2. Subchapter B, Chapter 32, Human Resources Code,
- 17 is amended by adding Section 32.079 to read as follows:
- 18 Sec. 32.079. REIMBURSEMENT FOR CERTAIN COUNSELING
- 19 SERVICES. (a) Subject to Subsection (b), the commission shall
- 20 provide reimbursement under the medical assistance program to a
- 21 provider described by Section 32.027(m) who is selected by a
- 22 recipient of medical assistance and who provides a service or
- 23 procedure covered under the medical assistance program that the
- 24 provider is authorized by law to perform. The commission shall
- 25 ensure that the provider is reimbursed at a rate equal to 50 percent
- 26 of the reimbursement rate established for a licensed psychiatrist
- 27 or licensed psychologist for providing similar services.

- 1 (b) The commission shall ensure that reimbursement provided
- 2 to a provider under Subsection (a) is limited to not more than 3,000
- 3 hours or, if applicable, the number of hours of clinical practice or
- 4 other experience the provider is required to complete to qualify
- 5 for the applicable license.
- 6 <u>(c) This section shall be liberally construed.</u>
- 7 SECTION 3. If before implementing any provision of this Act
- 8 a state agency determines that a waiver or authorization from a
- 9 federal agency is necessary for implementation of that provision,
- 10 the agency affected by the provision shall request the waiver or
- 11 authorization and may delay implementing that provision until the
- 12 waiver or authorization is granted.
- 13 SECTION 4. This Act takes effect September 1, 2025.
