- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 ARTICLE 1. SHORT TITLE
- 6 SECTION 1.001. This Act may be cited as the Healthcare
- 7 Expanded and Accessed Locally for Texans (HEAL Texans) Act.
- 8 ARTICLE 2. ADVANCED PRACTICE REGISTERED NURSES
- 9 SECTION 2.001. Section 301.002, Occupations Code, is
- 10 amended to read as follows:
- 11 Sec. 301.002. DEFINITIONS. In this chapter:
- 12 (1) "Advanced practice registered nurse" means a
- 13 registered nurse licensed by the board to practice as an advanced
- 14 practice registered nurse on the basis of completion of an advanced
- 15 educational program. The term includes a nurse practitioner, nurse
- 16 midwife, nurse anesthetist, and clinical nurse specialist.
- 17 $\underline{(2)}$ [(1)] "Board" means the Texas Board of Nursing.
- 18 $\underline{\text{(3)}}$ [\frac{(1-a)}{}] "Chief nursing officer" means the
- 19 registered nurse who is administratively responsible for the
- 20 nursing services at a facility.
- 21 (4) "Controlled substance" has the meaning assigned by
- 22 <u>Section 481.002</u>, <u>Health and Safety Code</u>.
- 23 (5) "Dangerous drug" has the meaning assigned by
- 24 Section 483.001, Health and Safety Code.

- 1 (6) "Device" has the meaning assigned by Section
- 2 551.003 and includes durable medical equipment.
- 3 (7) "Nonprescription drug" has the meaning assigned by
- 4 <u>Section 551.003.</u>
- 5 (8) "Nurse" means a person required to be licensed
- 6 under this chapter to engage in professional or vocational nursing.
- 7 (9) "Nursing" means professional or vocational
- 8 nursing.
- 9 (10) $\left[\frac{(1-b)}{1-b}\right]$ "Patient safety committee" has the
- 10 meaning assigned by Section 303.001.
- 11 (11) "Prescribe or order a drug or device" has the
- 12 meaning assigned by Section 157.051.
- 13 (12) $\left[\frac{(2)}{2}\right]$ "Professional nursing" means the
- 14 performance of an act that requires substantial specialized
- 15 judgment and skill, the proper performance of which is based on
- 16 knowledge and application of the principles of biological,
- 17 physical, and social science as acquired by a completed course in an
- 18 approved school of professional nursing. The term does not include
- 19 acts of medical diagnosis or the prescription of therapeutic or
- 20 corrective measures, except as authorized for an advanced practice
- 21 <u>registered nurse</u>. Professional nursing involves:
- (A) the observation, assessment, intervention,
- 23 evaluation, rehabilitation, care and counsel, or health teachings
- 24 of a person who is ill, injured, infirm, or experiencing a change in
- 25 normal health processes;
- 26 (B) the maintenance of health or prevention of
- 27 illness;

- 12 (E) assisting in the evaluation of an
- 13 individual's response to a nursing intervention and the
- 14 identification of an individual's needs; and
- 15 (F) engaging in other acts that require education
- 16 and training, as prescribed by board rules and policies,
- 17 commensurate with the nurse's experience, continuing education,
- 18 and demonstrated competency.
- 19 SECTION 2.002. Section 301.005(b), Occupations Code, is
- 20 amended to read as follows:
- 21 (b) A reference in any other law to an "advanced nurse
- 22 practitioner, [ex] "advanced practice nurse, or "advanced
- 23 practice registered nurse" means an advanced practice registered
- 24 nurse.
- 25 SECTION 2.003. Section 301.152, Occupations Code, is
- 26 transferred to Subchapter H, Chapter 301, Occupations Code,
- 27 redesignated as Section 301.357, Occupations Code, and amended to

- 1 read as follows:
- 2 Sec. 301.357 [301.152]. ADVANCED PRACTICE REGISTERED NURSES
- 3 [RULES RECARDING SPECIALIZED TRAINING]. (a) Advanced practice
- 4 registered nursing includes:
- 5 (1) ordering, performing, and interpreting diagnostic
- 6 tests;
- 7 (2) formulating primary and differential medical
- 8 diagnoses and advanced assessments;
- 9 (3) treating actual and potential health problems;
- 10 (4) prescribing therapeutic and corrective measures,
- 11 including nutrition and diagnostic support services, home health
- 12 care, hospice care, physical therapy, and occupational therapy, and
- 13 delegating and assigning the performance of therapeutic and
- 14 corrective measures to assistive personnel;
- 15 (5) to the extent authorized by the board under
- 16 Section 301.358, prescribing, ordering, procuring, administering,
- 17 and dispensing drugs and devices, including blood and blood
- 18 products, controlled substances listed in Schedules II, III, IV,
- 19 and V, dangerous drugs, and nonprescription drugs;
- 20 (6) providing referrals to health care agencies,
- 21 health care providers, and community resources;
- 22 (7) serving as the primary care provider of record;
- 23 <u>and</u>
- 24 (8) performing other acts that require education and
- 25 <u>training consistent with professional standards and that are</u>
- 26 commensurate with the advanced practice registered nurse's
- 27 education, licensure, and demonstrated competencies and

- 1 <u>experience</u>. [In this section, "advanced practice registered nurse"
- 2 means a registered nurse licensed by the board to practice as an
- 3 advanced practice registered nurse on the basis of completion of an
- 4 advanced educational program. The term includes a nurse
- 5 practitioner, nurse midwife, nurse anesthetist, and clinical nurse
- 6 specialist. The term is synonymous with "advanced nurse
- 7 practitioner" and "advanced practice nurse."]
- 8 (b) The board shall adopt rules to:
- 9 (1) license a registered nurse as an advanced practice 10 registered nurse;
- 11 (2) establish:
- 12 (A) any specialized education or training,
- 13 including pharmacology, that an advanced practice registered nurse
- 14 must have to prescribe or order a drug or device as authorized
- 15 [delegated] by the board [a physician] under Section 301.358
- 16 [157.0512 or 157.054];
- 17 (B) a system for approving an advanced practice
- 18 registered nurse to prescribe or order a drug or device as
- 19 <u>authorized</u> [delegated] by <u>the board</u> [a physician] under Section
- 20 301.358 [157.0512 or 157.054] on the receipt of evidence of
- 21 completing the specialized education and training requirement
- 22 under Paragraph (A); and
- (C) a system for issuing a prescription
- 24 authorization number to an advanced practice registered nurse
- 25 approved under Paragraph (B); and
- 26 (3) concurrently renew any license or approval granted
- 27 to an advanced practice registered nurse under this subsection and

- 1 a license renewed by the advanced practice registered nurse under
- 2 Section 301.301.
- 3 (c) At a minimum, the rules adopted under Subsection (b)(2)
- 4 must:
- 5 (1) require completion of pharmacology and related
- 6 pathophysiology education for initial approval; and
- 7 (2) require continuing education in clinical
- 8 pharmacology and related pathophysiology in addition to any
- 9 continuing education otherwise required under Section 301.303.
- 10 (d) The signature of an advanced practice registered nurse
- 11 attesting to the provision of a legally authorized service by the
- 12 advanced practice registered nurse satisfies any documentation
- 13 requirement for that service established by a state agency.
- 14 (e) An advanced practice registered nurse shall practice as
- 15 <u>a licensed independent practitioner in accordance with standards</u>
- 16 <u>established</u> and recognized by the board to protect the public
- 17 health and safety.
- (f) An advanced practice registered nurse is accountable to
- 19 patients, the nursing profession, and the board for:
- 20 (1) complying with the requirements of this chapter;
- 21 (2) providing quality advanced nursing care;
- 22 (3) recognizing the nurse's limits of knowledge;
- 23 (4) planning for the management of situations beyond
- 24 the nurse's expertise; and
- 25 (5) consulting with or referring patients to other
- 26 health care providers as appropriate.
- 27 (g) This section does not limit or modify the scope of

- 1 practice of a registered nurse who is not an advanced practice
- 2 <u>registered nurse.</u>
- 3 (h) Notwithstanding any other law, an advanced practice
- 4 registered nurse performing an act described by Subsection (a) is
- 5 not considered to be practicing medicine without a license.
- 6 SECTION 2.004. Section 301.354(a), Occupations Code, is
- 7 amended to read as follows:
- 8 (a) In this section, "nurse first assistant" means a
- 9 registered nurse who:
- 10 (1) has completed a nurse first assistant educational
- 11 program approved or recognized by an organization recognized by the
- 12 board; and
- 13 (2) $\left[\frac{is}{is}\right]$ either:
- 14 (A) is certified in perioperative nursing by an
- 15 organization recognized by the board; or
- 16 (B) is [recognized by the board as] an advanced
- 17 practice registered nurse [and] qualified by education, training,
- 18 or experience to perform the tasks involved in perioperative
- 19 nursing.
- SECTION 2.005. Subchapter H, Chapter 301, Occupations Code,
- 21 is amended by adding Section 301.358 to read as follows:
- Sec. 301.358. PRESCRIBING AND ORDERING AUTHORITY OF
- 23 ADVANCED PRACTICE REGISTERED NURSE. The board may authorize an
- 24 advanced practice registered nurse to prescribe and order drugs and
- 25 devices, including controlled substances listed in Schedules II,
- 26 III, IV, and V, dangerous drugs, and nonprescription drugs.

- 25 (5) provide a general plan for addressing consultation
- 26 and referral;
- 27 (6) provide a plan for addressing patient emergencies;

- 1 (7) state the general process for communication and
- 2 the sharing of information between the physician and the [advanced
- 3 practice registered nurse or] physician assistant to whom the
- 4 physician has delegated prescriptive authority related to the care
- 5 and treatment of patients;
- 6 (8) if alternate physician supervision is to be
- 7 utilized, designate one or more alternate physicians who may:
- 8 (A) provide appropriate supervision on a
- 9 temporary basis in accordance with the requirements established by
- 10 the prescriptive authority agreement and the requirements of this
- 11 subchapter; and
- 12 (B) participate in the prescriptive authority
- 13 quality assurance and improvement plan meetings required under this

- 16 assurance and improvement plan and specify methods for documenting
- 17 the implementation of the plan that include the following:
- 18 (A) chart review, with the number of charts to be

- 21 (B) periodic meetings between the [advanced
- 22 practice registered nurse or] physician assistant and the

- 24 (f) The periodic meetings described by Subsection (e)(9)(B)

- 27 (A) the sharing of information relating to

- 1 patient treatment and care, needed changes in patient care plans,
- 2 and issues relating to referrals; and
- 3 (B) discussion of patient care improvement;
- 4 (2) be documented; and
- 5 (3) take place at least once a month in a manner
- 6 determined by the physician and the [advanced practice registered
- 7 nurse or] physician assistant.
- 8 (g) The prescriptive authority agreement may include other
- 9 provisions agreed to by the physician and [advanced practice
- 10 registered nurse or] physician assistant.
- 11 (i) The prescriptive authority agreement need not describe
- 12 the exact steps that a [an advanced practice registered nurse or]
- 13 physician assistant must take with respect to each specific
- 14 condition, disease, or symptom.
- 15 (j) A physician[, advanced practice registered nurse,] or
- 16 physician assistant who is a party to a prescriptive authority
- 17 agreement must retain a copy of the agreement until the second
- 18 anniversary of the date the agreement is terminated.
- 19 (1) In the event that a party to a prescriptive authority
- 20 agreement is notified that the individual has become the subject of
- 21 an investigation by the board[, the Texas Board of Nursing,] or the
- 22 Texas Physician Assistant Board, the individual shall immediately
- 23 notify the other party to the prescriptive authority agreement.
- 24 (m) The prescriptive authority agreement and any amendments
- 25 must be reviewed at least annually, dated, and signed by the parties
- 26 to the agreement. The prescriptive authority agreement and any
- 27 amendments must be made available to the board[, the Texas Board of

- 1 $\frac{\text{Nursing}_{r}}{\text{Nursing}_{r}}$] or the Texas Physician Assistant Board not later than the
- 2 third business day after the date of receipt of request, if any.
- 3 (n) The prescriptive authority agreement should promote the
- 4 exercise of professional judgment by the [advanced practice
- 5 registered nurse or] physician assistant commensurate with the
- 6 [advanced practice registered nurse's or] physician assistant's
- 7 education and experience and the relationship between the [advanced
- 8 practice registered nurse or] physician assistant and the
- 9 physician.
- 10 (o) This section shall be liberally construed to allow the
- 11 use of prescriptive authority agreements to safely and effectively
- 12 utilize the skills and services of [advanced practice registered
- 13 nurses and] physician assistants.
- 14 SECTION 3.005. Section 157.0513, Occupations Code, is
- 15 amended to read as follows:
- 16 Sec. 157.0513. PRESCRIPTIVE AUTHORITY AGREEMENT:
- 17 INFORMATION. (a) The board[, the Texas Board of Nursing,] and the
- 18 Texas Physician Assistant Board shall jointly develop a process:
- 19 (1) to exchange information regarding the names,
- 20 locations, and license numbers of each physician[, advanced
- 21 practice registered nurse, and physician assistant who has entered
- 22 into a prescriptive authority agreement;
- 23 (2) by which each board shall immediately notify the
- 24 other board [boards] when a license holder of the board becomes the
- 25 subject of an investigation involving the delegation and
- 26 supervision of prescriptive authority, as well as the final
- 27 disposition of any such investigation;

- 1 (3) by which each board shall maintain and share a list
- 2 of the board's license holders who have been subject to a final
- 3 adverse disciplinary action for an act involving the delegation and
- 4 supervision of prescriptive authority; and
- 5 (4) to ensure that each [advanced practice registered
- 6 nurse or] physician assistant who has entered into a prescriptive
- 7 authority agreement authorizing the prescribing of opioids is
- 8 required to complete not less than two hours of continuing
- 9 education annually regarding safe and effective pain management
- 10 related to the prescription of opioids and other controlled
- 11 substances, including education regarding:
- 12 (A) reasonable standards of care;
- 13 (B) the identification of drug-seeking behavior
- 14 in patients; and
- 15 (C) effectively communicating with patients
- 16 regarding the prescription of an opioid or other controlled
- 17 substance.
- 18 (b) If the board[, the Texas Board of Nursing,] or the Texas
- 19 Physician Assistant Board receives a notice under Subsection
- 20 (a)(2), the board that received notice may open an investigation
- 21 against a license holder of the board who is a party to a
- 22 prescriptive authority agreement with the license holder who is
- 23 under investigation by the board that provided notice under
- 24 Subsection (a)(2).
- 25 (c) The board shall maintain and make available to the
- 26 public a searchable online list of physicians[, advanced practice
- 27 registered nurses, and physician assistants who have entered into

- 1 a prescriptive authority agreement authorized under Section
- 2 157.0512 and identify the physician[, advanced practice registered
- 3 nurse, or physician assistant] with whom each [physician, advanced
- 4 practice registered nurse, and] physician assistant has entered
- 5 into a prescriptive authority agreement.
- 6 (d) The board shall collaborate with the [Texas Board of
- 7 Nursing and the] Texas Physician Assistant Board to maintain and

- 12 SECTION 3.006. Sections 157.054(a), (a-1), (b), and (c),
- 13 Occupations Code, are amended to read as follows:
- 14 (a) One or more physicians licensed by the board may
- 15 delegate, to one or more physician assistants [or advanced practice
- 16 registered nurses] acting under adequate physician supervision
- 17 whose practice is facility-based at a hospital or licensed
- 18 long-term care facility, the administration or provision of a drug
- 19 and the prescribing or ordering of a drug or device if each of the
- 20 delegating physicians is:
- 21 (1) the medical director or chief of medical staff of
- 22 the facility in which the physician assistant [or advanced practice
- 23 registered nurse] practices;
- 24 (2) the chair of the facility's credentialing
- 25 committee;
- 26 (3) a department chair of a facility department in
- 27 which the physician assistant [or advanced practice registered

1 nurse practices; or

- 2 (4) a physician who consents to the request of the 3 medical director or chief of medical staff to delegate the 4 prescribing or ordering of a drug or device at the facility in which 5 the physician assistant [or advanced practice registered nurse]
- 6 practices.
- 7 (a-1) The <u>limit</u> [<u>limits</u>] on the number of [<u>advanced practice</u>
 8 <u>registered nurses or</u>] physician assistants to whom a physician may
 9 delegate under Section 157.0512 <u>does</u> [<u>do</u>] not apply to a physician
 10 under Subsection (a) whose practice is facility-based under this
 11 section, provided that the physician is not delegating in a
 12 freestanding clinic, center, or practice of the facility.
- 13 (b) A physician's authority to delegate under Subsection 14 (a) is limited as follows:
- (1) the delegation must be made under a physician's order, standing medical order, standing delegation order, or another order or protocol developed in accordance with policies approved by the facility's medical staff or a committee of the facility's medical staff as provided by the facility bylaws;
