4	SECTION 1. Subtitle B, Title 2, Health and Safety Code, is
5	amended by adding Chapter 52B to read as follows:
6	CHAPTER 52B. SICKLE CELL DISEASE REGISTRY
7	Sec. 52B.001. DEFINITION. In this chapter, "health care
8	facility" means:
9	(1) a hospital licensed under Chapter 241; or
10	(2) any other facility that provides diagnostic or
11	treatment services to patients with sickle cell disease.
12	Sec. 52B.002. REGISTRY; CONTENTS. (a) The department shall
13	establish and maintain a sickle cell disease registry in accordance
14	with this chapter for use as a single repository of accurate,
15	complete records of sickle cell disease cases to aid in the cure and
16	treatment of sickle cell disease in this state.
17	(b) The sickle cell disease registry must include:
18	(1) a record of sickle cell disease cases that occur in
19	this state; and
20	(2) any other information concerning sickle cell
21	disease cases the executive commissioner considers necessary and
22	appropriate to assist with the cure or treatment of sickle cell
23	disease.

No. 1884 care facility shall provide to the department, in the form and 1 2 manner the department prescribes, data the department considers 3 necessary and appropriate concerning sickle cell disease cases. 4 Sec. 52B.004. DEPARTMENT POWERS; RULES. (a) To implement 5 this chapter, the department may: 6 (1) execute necessary contracts; (2) receive data from health care facilities 7 8 concerning sickle cell disease cases to record and analyze the data directly related to the disease; and 9 10 (3) compile and publish statistical and other studies derived from data obtained under this chapter to provide, in an 11 12 accessible form, information useful to physicians, other medical personnel, and the public. 13 14 (b) The executive commissioner shall adopt rules to 15 implement this chapter. 16 (c) The executive commissioner by rule shall develop 17 guidelines to: 18 (1) obtain data from health care facilities regarding 19 sickle cell disease cases; (2) protect the confidentiality of individuals 20 diagnosed with sickle cell disease in accordance with Section 21 22 159.002, Occupations Code; and (3) ensure the registry is developed in a manner 23 24 consistent with: 25 (A) the Health Insurance Portability and 26 Accountability Act of 1996 (Pub. L. No. 104-191) and regulations 27 adopted under that Act; and

1 (B) other applicable laws and regulations 2 governing disclosure of health information. 3 Sec. 52B.005. REPORTS. (a) The department shall submit an 4 annual report to the legislature on the information obtained under 5 this chapter. 6 (b) The department, in cooperation with other sickle cell disease reporting organizations and research institutions, may 7 publish reports the department determines are necessary to carry 8 9 out the purposes of this chapter. SECTION 2. As soon as practicable after the effective date 10 of this Act, the executive commissioner of the Health and Human 11 Services Commission shall adopt rules necessary to implement 12 Chapter 52B, Health and Safety Code, as added by this Act. 13 SECTION 3. This Act takes effect September 1, 2025. 14
