1-19 relating to vehicle safety inspections of certain travel trailers. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 1-20

SECTION 1. The heading to Section 548.510, Transportation Code, as amended by Chapters 851 (H.B. 3297) and 999 (H.B. 198), Acts of the 88th Legislature, Regular Session, 2023, is reenacted 1-21 1-22 1-23 1-24 to read as follows: 1-25

Sec. 548.510. INSPECTION PROGRAM REPLACEMENT FEE.

SECTION 2. Section 548.510(a), Transportation Code, as amended by Chapters 851 (H.B. 3297) and 999 (H.B. 198), Acts of the 88th Legislature, Regular Session, 2023, is reenacted to read as 1-26 1-27 1-28 1-29 follows:

(a) Except as provided by Subsections (b) and (c), in addition to other fees imposed at the time of registration, at the 1-30 1-31 time of application for initial registration or renewal of registration of a motor vehicle, trailer, semitrailer, pole 1-32 1-33 1-34 trailer, or mobile home, the applicant shall pay an annual fee of 1-35 \$7.50.

1-36 SECTION 3. Section 548.054, Transportation Code, is 1-37 repealed.

1-38 SECTION 4. This Act takes effect immediately if it receives 1-39 a vote of two-thirds of all the members elected to each house, as provided by Section 39, Article III, Texas Constitution. If this 1-40 1-41 Act does not receive the vote necessary for immediate effect, this 1-42 Act takes effect September 1, 2025.
