- SECTION 3. Subchapter B, Chapter 551, Insurance Code, is

- 2 <u>insurer that declines an application for a liability insurance or</u>

- 5 SECTION 4. Section 551.055, Insurance Code, is amended to

- 8 NONRENEWAL REQUIRED. In a notice to an applicant or insured
- 9 relating to declination, cancellation, or refusal to renew, an
- 10 insurer must state the reason for the <u>declination</u>, cancellation, or
- 11 nonrenewal. The statement must comply with:

- 13 (2) rules adopted under Section 551.002(d).
- 14 SECTION 5. Section 551.109, Insurance Code, is amended to
- 15 read as follows:
- Sec. 551.109. INSURER STATEMENT. An insurer shall [, at the
- 17 request of an applicant for insurance or an insured, provide a
- 18 written statement of the reason for a declination, cancellation, or
- 19 nonrenewal of an insurance policy. The statement must comply with:
- 20 (1) Sections 551.002(b) and (c); and
- 21 (2) rules adopted under Section 551.002(d).
- 22 SECTION 6. The change in law made by this Act applies only
- 23 to an application for insurance that is made or an insurance policy
- 24 that is delivered, issued for delivery, or renewed on or after the
- 25 effective date of this Act. An application made or policy
- 26 delivered, issued for delivery, or renewed before the effective
- 27 date of this Act is governed by the law as it existed immediately
