| 11 | Sec. 61.571. PROGRAM PURPOSE. The purpose of the Building |
| 12 | Better Futures Program is to facilitate the delivery by |
| 13 | institutions of higher education and private or independent |
| 14 | institutions of higher education of educational and occupational |
| 15 | skills training opportunities and support services to students with |
| 16 | intellectual and developmental disabilities in an inclusive and |
| 17 | age-appropriate environment. |
| 18 | Sec. 61.572. ADMINISTRATION; RULES. (a) The board shall |
| 19 | administer the Building Better Futures Program and adopt any rules |
| 20 | necessary to implement the program or this subchapter. |
| 21 | (b) The board may develop a competitive application process |
| 22 | for the award of funds to eligible institutions under the program. |
| 23 | (c) A program or course offered under the Building Better |
| 24 | Futures Program is exempt from the requirements of Sections 61.0512 |

- 2 Sec. 61.573. INSTITUTION ELIGIBILITY. (a) To be eligible
- 3 to participate in the Building Better Futures Program, an
- 4 institution of higher education or private or independent
- 5 institution of higher education must:
- 6 (1) be approved by or awaiting approval from the
- 7 United States Department of Education to offer a comprehensive
- 8 transition and postsecondary program for students with
- 9 intellectual or developmental disabilities;
- 10 (2) develop and implement a selective admissions
- 11 process to select eligible students under Section 61.574 for
- 12 admission to the institution's comprehensive transition and
- 13 postsecondary program; and
- 14 (3) award a certificate to each student who
- 15 successfully completes the Building Better Futures Program at the
- 16 <u>institution</u>.
- 17 (b) The board shall establish criteria to ensure that each
- 18 eligible institution that has requested but not yet received
- 19 approval from the United States Department of Education for the
- 20 institution's comprehensive transition and postsecondary program
- 21 obtains that approval not later than the third anniversary of the
- 22 date the institution is initially selected by the board for
- 23 participation in the Building Better Futures Program.
- Sec. 61.574. STUDENT ELIGIBILITY. (a) To be eligible to
- 25 participate in the Building Better Futures Program, an applicant
- 26 must:
- 27 (1) apply <u>for admission to a comprehensive transition</u>

- 1 and postsecondary program, or a program that is awaiting approval
- 2 from the United States Department of Education as a comprehensive
- 3 transition and postsecondary program, at an eligible institution;
- 4 (2) be a citizen or a lawful permanent resident of the
- 5 United States;
- 6 (3) subject to Subsection (d), be a resident of this
- 7 state as determined under Section 54.052;
- 8 (4) have an intellectual or developmental disability
- 9 diagnosed by a physician, psychologist, or other individual
- 10 qualified by license or statute to make the diagnosis;
- 11 (5) be able and willing to learn and participate in an
- 12 inclusive classroom and work setting; and
- 13 (6) not be a danger to the applicant's self or others,
- 14 as determined by the accepting institution.
- 15 (b) An applicant who is a lawful permanent resident of the
- 16 United States must submit with the applicant's application a copy
- 17 of the applicant's lawful permanent resident form.
- 18 (c) An eligible institution may require an applicant or the
- 19 applicant's parent or guardian to provide proof of residency as
- 20 follows:
- 21 (1) information from the Free Application for Federal
- 22 Student Aid;
- 23 (2) a current driver's license issued by the
- 24 Department of Public Safety;
- 25 (3) documentation of payment of personal or real
- 26 property taxes for the previous year;
- 27 (4) current vehicle registration issued by the Texas

- 1 Department of Motor Vehicles;
- 2 (5) a current voter registration certificate issued by
- 3 <u>a voter registrar of a county in this state; or</u>
- 4 (6) documentation described by Section 54.053.
- 5 (d) An applicant who is not a resident of this state may
- 6 participate in the Building Better Futures Program at an eligible
- 7 institution only if the applicant is otherwise eligible under this
- 8 section and the institution has an opening available in the program
- 9 after all other eligible applicants are admitted.
- Sec. 61.575. TRANSFERABILITY. Semester credit hours or the
- 11 equivalent completed through the Building Better Futures Program
- 12 may not be transferred to an associate or baccalaureate degree
- 13 program.
- 14 Sec. 61.576. AWARD OF MONEY. The board may award money
- 15 under the Building Better Futures Program only to eligible
- 16 institutions to be used by the institutions to facilitate the
- 17 delivery of educational and occupational skills training
- 18 opportunities and support services to students participating in the
- 19 program.
- Sec. 61.577. FUNDING. The board may use any available
- 21 revenue, including legislative appropriations, and may solicit and
- 22 <u>accept gifts, grants, and donations from a public or private source</u>
- 23 for the purposes of this subchapter.
- 24 SECTION 2. The Texas Higher Education Coordinating Board
- 25 shall adopt rules to administer Subchapter J-2, Chapter 61,
- 26 Education Code, as added by this Act, as soon as practicable after
- 27 the effective date of this Act.
