4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter A, Chapter 13, Election Code, is
6	amended by adding Sections 13.009 and 13.010 to read as follows:
7	Sec. 13.009. VOTER REGISTRATION THROUGH DEPARTMENT OF
8	PUBLIC SAFETY. (a) The voter registrar of each county shall
9	automatically register any county resident who is eligible to vote
10	as provided by Section 13.001 and:
11	(1) is issued a Texas driver's license or a personal
12	identification card by the Department of Public Safety; or
13	(2) makes a change to a Texas driver's license or
14	personal identification card issued by the Department of Public
15	Safety.
16	(b) A driver's license or personal identification card
17	transaction with an indication provided by Section 20.062(b) or
18	20.063(c) that the transaction is not for voter registration
19	purposes is not subject to this section.
20	Sec. 13.010. VOTER REGISTRATION THROUGH VOTER REGISTRATION

- 8 SECTION 2. Section 20.002, Election Code, is amended to
- 9 read as follows:
- 10 Sec. 20.002. AGENCY-PRESCRIBED REGISTRATION APPLICATION
- 11 FORM. (a) A voter registration agency under this subchapter shall
- 12 prescribe and use a form and procedure that combines a form for
- 13 services from that agency with an officially prescribed voter
- 14 registration application form.
- 15 (b) A voter registration agency under this subchapter shall
- 16 prescribe and use a form and procedure that requests a person's
- 17 address and that combines agency and voter registration functions.
- 18 The form must allow a person to indicate that a change of address is
- 19 not for voter registration purposes.
- 20 (c) The design, content, and physical characteristics of
- 21 the agency forms must be [Instead of using the official voter
- 22 registration application form prescribed by the secretary of state,
- 23 a voter registration agency may use an official form prescribed by
- 24 the agency, if approved by the secretary of state.
- 25 SECTION 3. Section 20.032(a), Election Code, is amended to
- 26 read as follows:
- 27 (a) An appropriate agency employee shall [routinely] inform

- 5 SECTION 4. Section 20.061, Election Code, is amended to

- 7 Sec. 20.061. APPLICABILITY OF OTHER PROVISIONS. The other
- 8 provisions of this chapter apply to the Department of Public Safety
- 9 except provisions that conflict with this subchapter or Section
- 10 13.009.
- SECTION 5. Section 20.062(b), Election Code, is amended to
- 12 read as follows:
- 13 (b) The department shall prescribe and use a change of
- 14 address form and procedure that combines department and voter
- 15 registration functions. The form must allow a licensee or
- 16 cardholder to indicate that [whether] the change of address is not
- 17 [also to be used] for voter registration purposes.
- 18 SECTION 6. Section 20.063, Election Code, is amended to
- 19 read as follows:
- Sec. 20.063. REGISTRATION PROCEDURES. (a) The Department
- 21 of Public Safety shall consider an application made in person, by
- 22 mail, or online at the department's Internet website [provide to
- 23 each person who applies in person at the department's offices] for
- 24 an original or renewal of a driver's license, a personal
- 25 identification card, or a duplicate or corrected license or card by
- 26 a person who is eligible to vote as provided by Section 13.001 an
- 27 application for [opportunity to complete a] voter registration.

- 1 The date of application is considered to be the date of submission
- 2 to the voter registrar for the purpose of determining the effective
- 3 date of registration [application form].
- 4 (b) The Department of Public Safety shall consider a change
- 5 of address that relates to [When the department processes] a
- 6 license or card <u>and that is submitted to</u> [for renewal by mail,] the
- 7 department [shall deliver to the applicant by mail a voter
- 8 registration application form.
- 9 [(c) A change of address that relates to a license or card
- 10 and that is submitted to the department] in person, [or] by mail, or
- 11 <u>online at the department's Internet website</u> [serves] as a change <u>in</u>
- 12 [of address for] voter registration [unless the licensee or
- 13 cardholder indicates that the change is not for voter registration
- 14 purposes]. The date of submission of a change of address to a
- 15 department employee is considered to be the date of submission to
- 16 the voter registrar for the purpose of determining the effective
- 17 date of registration [only].
- 18 (c) The registration of an eligible [<del>(d) If a completed</del>]
- 19 voter as required by Subsections (a) and (b) is automatic unless the
- 20 person indicates that the transaction is not for voter
- 21 registration <u>purposes</u> [application submitted to a department
- 22 employee does not include the applicant's correct driver's license
- 23 number or personal identification card number, a department
- 24 employee shall enter the appropriate information on the
- 25 application. If a completed application does not include the
- 26 applicant's correct residence address or mailing address, a
- 27 department employee shall obtain the appropriate information from

- 2 SECTION 7. Section 20.065(b), Election Code, is amended to
- 3 read as follows:
- 4 (b) Each weekday the department is regularly open for
- 5 business, the department shall electronically transfer to the
- 6 secretary of state the name and information designated by the
- 7 <u>secretary of state for [of each person who completes a</u>] voter
- 8 registration for each individual who is eligible to vote as
- 9 provided by Section 13.001 and applies in person, by mail, or online
- 10 at the department's Internet website for an original or renewal of a
- 11 driver's license, a personal identification card, or a duplicate or
- 12 corrected license or card [application submitted to the
- 13 department]. The secretary shall prescribe procedures necessary to
- 14 implement this subsection.
- 15 SECTION 8. This Act takes effect September 1, 2025.
