2	relating to the transfer of students between public schools.
3	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
4	SECTION 1. Section 25.001, Education Code, is amended by
5	amending Subsection (h) and adding Subsection (k) to read as
6	follows:
7	(h) In addition to the penalty provided by Section 37.10,
8	Penal Code, a person who knowingly falsifies information on a form
9	required for enrollment of a student in a school district is liable
10	to the district if the student is not eligible for enrollment in the
11	district but is enrolled on the basis of the false information. The
12	person is liable, for the period during which the ineligible
13	student is enrolled, for [the greater of:
14	[(1) the maximum tuition fee the district may charge
15	under Section 25.038; or
1 (

- 16 $\left[\frac{(2)}{2}\right]$ the amount the district has budgeted for each student as maintenance and operating expenses.
- 18 (k) Notwithstanding any other law, a school district shall
 19 allow a student who qualifies for admission under this subchapter
 20 to enroll at the campus nearest to the student's residence offering
 21 the appropriate grade level, regardless of whether the student
 22 resides in the attendance zone of that district or campus and
 23 provided that the campus has capacity, as determined under Section
 24 25.046.

- 1 SECTION 2. Section 25.036, Education Code, is amended to 2 read as follows:
- 3 Sec. 25.036. TRANSFER OF STUDENT. (a) Any child, other
- 4 than a high school graduate, who is younger than 21 years of age and
- 5 eligible for enrollment on September 1 of any school year may apply
- 6 \underline{to} transfer [annually] from the child's school district [\underline{of}
- 7 residence to any public school [another district] in this state
- 8 that offers the appropriate grade level and has capacity, as
- 9 determined under Section 25.046 [if both the receiving district and
- 10 the applicant parent or guardian or person having lawful control of
- 11 the child jointly approve and timely agree in writing to the
- 12 transfer].
- 13 (b) Before the beginning of each school year, a school
- 14 district shall:
- 15 (1) require a transfer applicant under Subsection (a)
- 16 to complete and submit the district's transfer application form by
- 17 a reasonable deadline established by the district; and
- 18 (2) admit each eligible transfer applicant until
- 19 enrollment at the campus reaches capacity, as determined under
- 20 Section 25.046.
- 21 <u>(c) If a school district receives more eligible transfer</u>
- 22 applications for a district campus or a specific grade level at a
- 23 district campus than the district has capacity for at that campus or
- 24 in that grade level, as determined under Section 25.046, the
- 25 district shall fill the available positions by lottery. A school
- 26 district shall offer to a student who the district does not enroll
- 27 due to lack of capacity an available position, if any, in the

- 1 appropriate grade level at another district campus.
- 2 (d) A school district that must fill positions by lottery
- 3 under Subsection (c) shall, in developing the lottery system,
- 4 ensure priority is given to an applicant who:
- 5 (1) resides in the district;
- 6 (2) is enrolled as a transfer student in the district
- 7 <u>at another campus but has completed the highest grade level offered</u>
- 8 at that campus;
- 9 (3) is a sibling of a student currently enrolled at a
- 10 district campus;
- 11 (4) is applying to transfer to a campus that is the
- 12 campus geographically nearest to the student's residence that
- 13 offers the appropriate grade level, regardless of whether the
- 14 student resides in the attendance zone of that campus;
- 15 (5) receives special education services under
- 16 Subchapter A, Chapter 29;
- 17 (6) is in foster care; or
- 18 (7) is a dependent of a person who is employed at the
- 19 campus to which the student is applying to transfer.
- 20 (e) A school district that receives more eligible transfer
- 21 applications for a district campus or a specific grade level at a
- 22 district campus than the district may enroll at the capacity
- 23 determined under Section 25.046 for that campus or grade level
- 24 shall establish and maintain a waiting list for transfer applicants
- 25 who are not admitted.
- 26 (f) If a position at a school district campus with a
- 27 waitlist under Subsection (e) becomes available after the start of

- 1 the school year, the district shall first admit transfer applicants
- 2 according to that waitlist and then admit any additional transfer
- 3 applicants in the order in which those additional transfer
- 4 applications are received.
- 5 (g) A school district may not deny a student's transfer
- 6 application unless:
- 7 (1) the requested district or campus is determined to
- 8 be at capacity under Section 25.046; or
- 9 (2) the student requesting the transfer is, at the
- 10 <u>time of the application:</u>
- 11 (A) expelled or suspended from the student's
- 12 school;
- 13 (B) placed in a disciplinary alternative
- 14 education program or juvenile justice alternative education
- 15 program; or
- (C) subject to an ongoing disciplinary
- 17 proceeding under a district's student code of conduct adopted under
- 18 Section 37.001 that may lead to the student's:
- 19 (i) out-of-school suspension;
- 20 (ii) placement in a disciplinary
- 21 <u>alternative education program or juvenile justice alternative</u>
- 22 <u>education program; or</u>
- 23 <u>(iii) expulsion.</u>
- (h) Notwithstanding any other law, a transfer applicant
- 25 under this section may only appeal a denial of the applicant's
- 26 transfer application as provided by this subsection. The parent of
- 27 or person standing in parental relation to a student may appeal a

1 denial of the student's transfer application by submitting the 2 appeal not later than the 10th day after the date of notification of 3 the application denial to the board of trustees of the receiving school district. The receiving school district must consider the 4 5 appeal at the board's next regularly scheduled meeting and notify the parent of the board's decision not later than the 10th day after 6 7 the date of that meeting. If the receiving school district board of 8 trustees denies the appeal, the parent of or person standing in parental relation to the student may appeal that denial by 9 submitting the appeal to the commissioner not later than the 10th 10 day after the date of notification of the board's denial of the 11 12 appeal. The commissioner must provide a decision regarding an appeal received under this subsection not later than the 90th day 13 after the date the commissioner receives notice of the appeal. The 14 15 commissioner must allow the appealing person and a representative from the receiving school district to provide comment to the 16 17 commissioner regarding the appeal. An appeal under this subsection must be submitted on a form approved by the commissioner. 18

- (i) A student who transfers to another school district or

 20 district campus as provided by this section may remain at the

 21 receiving campus until that student completes the highest grade

 22 level offered at the campus.
- (j) Once a student who transfers to another school district
 or district campus as provided by this section completes the
 highest grade level offered at the receiving campus, the student
 must reapply to continue attending school in the receiving
 district. The district must prioritize admitting the student as

- 1 provided by Subsection (d).
- 2 (k) A school district may not deny admission to a student
- 3 who resides in the attendance zone of the district, including a
- 4 student who attends an open-enrollment charter school in the
- 5 district, for the purpose of accepting a transfer applicant under
- 6 this section.
- 7 (1) A school district campus that uses a selective
- 8 admissions process in accordance with a specific instructional
- 9 model or performing arts focus may retain that selective admissions
- 10 process if the admissions process prohibits discrimination on the
- 11 basis of a student's:
- 12 (1) sex, national origin, ethnicity, religion,
- 13 disability, socioeconomic status, or athletic ability;
- 14 (2) disciplinary record, except as permitted under
- 15 Subsection (g); or
- 16 (3) assigned school district or district campus based
- 17 on the attendance zone of the student's residence.
- 18 (m) The commissioner shall adopt rules necessary to
- 19 implement this section, including rules establishing:
- 20 (1) an admissions lottery, as described by Subsection
- 21 (c), and a waitlist as described by Subsection (e);
- 22 (2) procedures to ensure that selective admissions
- 23 processes at applicable open-enrollment district campuses comply
- 24 with Subsection (1); and
- 25 (3) procedures to ensure this section complies with
- 26 state and federal law regarding confidentiality of student medical
- 27 or educational information, including the Health Insurance

- 1 Portability and Accountability Act of 1996 (42 U.S.C. Section 1320d
- 2 et seq.) and the Family Educational Rights and Privacy Act of 1974
- 3 (20 U.S.C. Section 1232g).
- 4 (n) [A transfer agreement under this section shall be filed
- 5 and preserved as a receiving district record for audit purposes of
- 6 the agency.
- 7 $\left[\frac{(c)}{c}\right]$ In the case of a transfer under this section, a
- 8 child's school district of residence shall provide the receiving
- 9 district with the child's disciplinary record and any threat
- 10 assessment involving the child's behavior conducted under Section
- 11 37.115.
- 12 SECTION 3. Subchapter B, Chapter 25, Education Code, is
- 13 amended by adding Sections 25.046 and 25.047 to read as follows:
- 14 Sec. 25.046. TRANSFER CAPACITY; DISTRICT POLICY. (a)
- 15 Except as provided by Subsection (c), each year on the first day of
- 16 January, April, July, and October, the board of trustees of a school
- 17 district shall determine the capacity of each district campus and
- 18 the capacity of each grade level offered at each campus. For
- 19 purposes of this section, the capacity of a district campus or a
- 20 grade level at that campus is the total number of students that may
- 21 be admitted at the campus or at that grade level, as applicable,
- 22 less the students who are currently enrolled at that campus or at
- 23 that grade <u>level</u>, <u>as applicable</u>. <u>Based on the board's</u>
- 24 determination of campus or grade level capacity and current student
- 25 enrollment, the district shall identify the number of available
- 26 positions at each campus and for each grade level. In determining
- 27 campus and grade level capacity, the district shall consult the

- 1 most recent district facility plan, including a facility plan
- 2 created as part of a district bond proposal.
- 3 (b) The district shall post for each campus in the district
- 4 on the district's Internet website, if the district maintains a
- 5 website, the most recent determination of campus and grade level
- 6 capacity. If the district does not maintain a website, the district
- 7 shall make the information required under this subsection available
- 8 to the public at a district administrative office.
- 9 (c) A school district is not required to determine the
- 10 capacity of a new instructional facility, as defined by Section
- 11 48.152, in the first school year in which students attend the new
- 12 instructional facility.
- 13 (d) The board of trustees of a school district shall adopt a
- 14 written policy that meets the requirements adopted by the
- 15 <u>commissioner under Subsection (f) for the admission of a transfer</u>
- 16 applicant under this subchapter. The board shall make the policy
- 17 available to the public in the same manner the district makes
- 18 available the district's determination of campus and grade level
- 19 capacity under Subsection (b). The policy must include:
- 20 (1) adoption of a transfer application form;
- 21 (2) the provision of the address of the district
- 22 administrative office where a person may access the district's
- 23 determination of campus and grade level capacity, if the district
- 24 does not maintain an Internet website; and
- 25 (3) the provision of information regarding available
- 26 options for transportation provided by the district or in the
- 27 community.

- 1 (e) The agency shall establish and maintain on the agency's
- 2 Internet website a publication that includes each school district's
- 3 policy adopted under this section and campus or grade level
- 4 capacity determinations under Subsection (a).
- 5 (f) The commissioner shall adopt rules and prescribe
- 6 procedures necessary to implement this section, including by
- 7 developing any necessary model policies, forms, or templates for
- 8 use by a school district in complying with Subsection (d). In
- 9 adopting rules to implement this section, the commissioner shall
- 10 consider feedback from districts and shall prioritize:
- 11 (1) flexibility of access for students;
- 12 (2) encouraging districts to accommodate student
- 13 transfers; and
- 14 (3) preventing districts from discouraging student
- 15 <u>transfers</u>.
- 16 Sec. 25.047. REPORTING AND AUDIT REQUIREMENTS. (a)
- 17 Subject to Subsection (b), each school district shall annually
- 18 submit not later than the last Friday in October of each school year
- 19 a report to the agency regarding the transfer of students to and
- 20 from the district during the preceding school year. The report must
- 21 <u>include:</u>
- 22 (1) for each district campus, the quarterly campus and
- 23 grade level capacity determinations under Section 25.046;
- 24 (2) for each campus, the number of transfer
- 25 applications for transfers to that campus the district received,
- 26 the number of applications that were granted, and the number of
- 27 applications that were denied, including the reason for the denial;

- 1 (3) the information described by Subdivisions (1) and
- 2 (2) aggregated for all campuses in the district; and
- 3 (4) for the purposes of demographic analysis, any
- 4 information required by the commissioner as necessary to identify
- 5 each student admitted to or denied admission to a campus in the
- 6 district who is or was previously enrolled in a public school in
- 7 this state.
- 8 (b) A school district with only one campus serving each
- 9 grade level is exempt from Subsection (a)(3).
- 10 (c) Not later than March 15 of each year, the agency shall
- 11 post on the agency's Internet website a report on the transfer and
- 12 assignment of students. The report must include:
- 13 <u>(1) a summary of school district admission practices</u>
- 14 relating to student transfer admissions;
- 15 (2) for the state, the aggregated data reported under
- 16 Subsection (a);
- 17 (3) for each district, the aggregated data reported
- 18 under Subsection (a);
- 19 (4) a demographic analysis of the students
- 20 transferring districts;
- 21 (5) a demographic analysis of the students
- 22 <u>transferring between campuses in the same district;</u>
- 23 (6) for each district, the number of transfer
- 24 applicants seeking admission or withdrawal, showing the potential
- 25 net change in enrollment; and
- 26 (7) for each district, the actual number of students
- 27 who transferred into or out of the district, showing the actual net

- 1 change in enrollment.
- 2 (d) Every sixth year, the agency shall publish a study of
- 3 statewide transfer trends that includes:
- 4 (1) the total number of students transferring
- 5 <u>districts and of students transferring between campuses in the same</u>
- 6 district;
- 7 (2) using data from the preceding six school years, an
- 8 analysis at the state and district levels of changes in:
- 9 (A) the number of districts and campuses
- 10 admitting transfer students;
- 11 (B) the number of students transferring
- 12 districts; and
- 13 (C) the number of students transferring between
- 14 campuses in the same district;
- 15 (3) a demographic analysis of the students
- 16 transferring districts and of the students transferring between
- 17 campuses in the same district;
- 18 (4) using data from the preceding six school years, an
- 19 analysis of the patterns of student movement between districts and
- 20 campuses, including a description of any characteristics that are
- 21 correlated with students transferring to or away from districts or
- 22 campuses;
- 23 (5) a summary of district practices regarding
- 24 transportation of transfer students;
- 25 (6) an explanation of the reasons students choose to
- 26 transfer districts or campuses and the barriers faced by students
- 27 in transferring districts or campuses;

- 1 (7) an explanation of the challenges restricting
- 2 districts from admitting more transfer students;
- 3 (8) performance outcomes for inter- and
- 4 intra-district transfer students, including changes in student
- 5 proficiency after the date of transfer; and
- 6 (9) the effects of inter-district transfers on test
- 7 scores and program offerings for sending and receiving districts.
- 8 (e) Each school year, the agency shall randomly select 10
- 9 percent of the school districts in this state and conduct an audit
- 10 of each district's capacity determination under Section 25.046 and
- 11 of each district's approved and denied transfer applications. If
- 12 the agency finds inaccurate reporting of capacity levels by a
- 13 school district, the agency shall set the capacity for the
- 14 district. Districts audited during the preceding two school years
- 15 may not be selected for audit.
- 16 <u>(f) The commissioner shall adopt rules necessary to</u>
- 17 implement this section.
- SECTION 4. Section 34.007(a), Education Code, is amended to
- 19 read as follows:
- 20 (a) A board of county school trustees or a school district
- 21 board of trustees may establish and operate an economical public
- 22 school transportation system:
- 23 (1) in the county or district, as applicable;
- 24 (2) outside the county or district, as applicable, if
- 25 the county or school district enters into an interlocal contract as
- 26 provided by Chapter 791, Government Code; or
