SECTION 2. Section 209.00592, Property Code, is amended by 17 adding Subsection (h) to read as follows: 18 19 (h) A county attorney may bring an action for injunctive relief to restrain or remedy a violation of this section. 20 21 SECTION 3. Section 209.00593, Property Code, is amended by adding Subsection (c-1) to read as follows: 22 23 (c-1) A county attorney may bring an action for injunctive 24 relief to restrain or remedy a violation of this section.

SECTION 4. Chapter 209, Property Code, is amended by adding
Section 209.018 to read as follows:

3 Sec. 209.018. BOARD ACTION; BOARD MEMBERS AND OFFICERS AS FIDUCIARIES. Except as provided by a declaration, bylaws, or this 4 5 chapter, the board shall act in all instances on behalf of the property owners' association if in the good-faith judgment of the 6 board the action is reasonable. Each officer or member of the board 7 8 is liable as a fiduciary of the owners for the officer's or member's acts or omissions. All acts of the property owners' association 9 must be by and through the board unless otherwise provided by the 10 declaration or bylaws or by law. 11

12 SECTION 5. (a) Section 209.0041, Property Code, as amended 13 by this Act, applies only to a vote held on or after the effective 14 date of this Act. A vote held before the effective date of this Act 15 is governed by the law as it existed immediately before that date, 16 and that law is continued in effect for that purpose.

(b) Section 209.018, Property Code, as added by this Act, applies only to an act or omission that occurs on or after the effective date of this Act. An act or omission that occurs before the effective date of this Act is governed by the law in effect on the date the act or omission occurred, and the former law is continued in effect for that purpose.
