5	SECTION 1. Section 1016.053, Special District Local Laws
6	Code, is amended to read as follows:
7	Sec. 1016.053. BALLOT <u>APPLICATION</u> [PETITION]. A person who
8	wants to have the person's name printed on the ballot as a candidate
9	for director must file <u>an application</u> with the board secretary <u>ir</u>
10	accordance with Chapter 144, Election Code [a petition requesting
11	that action. The petition must be:
12	[(1) signed by at least 10 registered taxpaying
13	voters; and
14	[(2) filed by the deadline imposed by Section 144.005,
15	Election Code].
16	SECTION 2. Section 1016.054, Special District Local Laws
17	Code, is amended to read as follows:
18	Sec. 1016.054. QUALIFICATIONS FOR OFFICE. (a) A person may
19	not be elected or appointed as a director unless the person is:
20	(1) a district resident; and
21	(2) a qualified voter[+
22	[(3) a freeholder; and
23	[(4) at least 18 years of age when elected or

24 appointed].

- 1 (b) A person may not be elected or appointed as a director if
- 2 the person is a district employee.
- 3 SECTION 3. Section 1016.057, Special District Local Laws
- 4 Code, is amended to read as follows:
- 5 Sec. 1016.057. OFFICERS. The board shall elect a
- 6 president, a vice president, and a secretary from among its
- 7 members.
- 8 SECTION 4. The heading to Section 1016.060, Special
- 9 District Local Laws Code, is amended to read as follows:
- 10 Sec. 1016.060. DISTRICT ADMINISTRATOR[+ ASSISTANT
- 11 ADMINISTRATOR].
- 12 SECTION 5. Section 1016.060(c), Special District Local Laws
- 13 Code, is amended to read as follows:
- 14 (c) The district administrator serves [and any assistant
- 15 $\frac{\text{administrator serve}}{\text{administrator serve}}$ at the will of the board and $\frac{\text{is}}{\text{administrator serve}}$ entitled
- 16 to the compensation determined by the board.
- 17 SECTION 6. Section 1016.110, Special District Local Laws
- 18 Code, is amended to read as follows:
- 19 Sec. 1016.110. CONSTRUCTION [OR PURCHASE] CONTRACTS. (a)
- 20 The board may enter into construction contracts for the district.
- 21 (b) The board may enter into a public work contract as
- 22 authorized under Chapter 2269, Government Code.
- (c) Chapter 2253, Government Code, as it relates to
- 24 performance and payment bonds, applies to the district's
- 25 construction contracts [A construction or purchase contract that
- 26 involves the expenditure of more than \$2,000 may be made only after
- 27 advertising in the manner provided by Chapter 252 and Subchapter Cr

- 1 Chapter 262, Local Covernment Code].
- 2 SECTION 7. Section 1016.160(a), Special District Local Laws
- 3 Code, is amended to read as follows:
- 4 (a) Except as otherwise provided by Section 1016.107(c) of
- 5 this code, Section 315.002, Health and Safety Code, this
- 6 subchapter, and Subchapter E of this chapter, the district may not
- 7 incur a debt [an obligation] payable from district revenue other
- 8 than the revenue on hand or to be on hand in the current and
- 9 following district fiscal years.
- 10 SECTION 8. The following provisions of the Special District
- 11 Local Laws Code are repealed:
- 12 (1) Section 1016.055; and
- 13 (2) Sections 1016.060(b) and (d).
- 14 SECTION 9. (a) The changes in law made by this Act to
- 15 Section 1016.053, Special District Local Laws Code, apply only to
- 16 an election ordered on or after the effective date of this Act.
- 17 (b) The changes in law made by this Act to Section 1016.054,
- 18 Special District Local Laws Code:
- 19 (1) do not affect the entitlement of a director
- 20 serving on the board of directors immediately before the effective
- 21 date of this Act to continue to serve on the board for the remainder
- 22 of the director's term;
- 23 (2) apply only to a member of the board of directors
- 24 elected or appointed to the board on or after the effective date of
- 25 this Act; and
- 26 (3) do not prohibit a director serving on the board of
- 27 directors on the effective date of this Act from being reelected or

- 1 reappointed to the board if the director has the qualifications
- 2 required for membership on the board under Section 1016.054,
- 3 Special District Local Laws Code, as amended by this Act.
- 4 SECTION 10. This Act takes effect immediately if it
- 5 receives a vote of two-thirds of all the members elected to each
- 6 house, as provided by Section 39, Article III, Texas Constitution.
- 7 If this Act does not receive the vote necessary for immediate
- 8 effect, this Act takes effect September 1, 2025.
