9	Sec. 2118.001. DEFINITION. In this chapter, "state agency"
10	means an agency, department, commission, bureau, board, office,
11	council, court, or other entity that is in any branch of state
12	government and that is created by the constitution or a statute of
13	this state. The term includes an institution of higher education as
14	defined by Section 61.003, Education Code.
15	Sec. 2118.002. REQUEST TO ACCEPT FEDERAL MONEY. (a) Except
16	as provided by Subsection (c), a state agency may not accept federal
17	money unless the agency first submits to the comptroller a request
18	to accept the money and the comptroller approves the request.
19	(b) A request by a state agency under Subsection (a) must
20	include:
21	(1) a detailed description of each condition or
22	limitation that will be imposed on the agency if the agency accepts
23	the money; and
24	(2) an estimate of the cost to implement the

No. 2832 1 conditions and limitations described by Subdivision (1). 2 (c) A state agency is not required to submit a request to the 3 comptroller to accept federal money if: 4 (1) the agency previously submitted a request to 5 accept federal money from the same source and for the same purposes to the comptroller under Subsection (a); 6 7 (2) the comptroller approved the previously submitted 8 request; and 9 (3) no conditions or limitations other than those 10 described in the previously submitted request will be imposed on the agency if the agency accepts the federal money, as determined by 11 12 the agency. Sec. 2118.003. COMPTROLLER REVIEW. (a) The comptroller 13 shall review and approve or deny a request received under Section 14 15 2118.002 as soon as practicable after receipt. 16 (b) The comptroller shall communicate to a state agency the 17 approval or denial of a request submitted by the agency under Section 2118.002 before the passing of any applicable federal 18 19 deadline regarding receipt of the money of which the comptroller is made aware in the request. 20 21 Sec. 2118.004. COPY OF REQUEST FOR CERTAIN OFFICIALS. On receipt of a request under Section 2118.002, the comptroller shall 22 provide a copy of the request to the governor, the lieutenant 23 24 governor, the speaker of the house of representatives, and the chairs of the standing legislative committees with primary 25 26 jurisdiction over appropriations. 27 Sec. 2118.005. RULES. The comptroller shall adopt rules

1	necessary to administer this chapter, including a rule prescribing
2	the form to be used by a state agency for purposes of making a
3	request under Section 2118.002.
4	SECTION 2. Chapter 2118, Government Code, as added by this
5	Act, applies only to federal money made available for receipt by a
6	state agency on or after the effective date of this Act.
7	SECTION 3. This Act takes effect September 1, 2025.
