A BILL TO BE ENTITLED

1	AN ACT
2	relating to requirements for courses in the core curriculum adopted
3	by public institutions of higher education.
4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter S, Chapter 61, Education Code, is
6	amended by adding Section 61.8221 to read as follows:
7	Sec. 61.8221. REQUIREMENTS FOR COURSES IN CORE CURRICULUM.
8	A course in an institution of higher education's core curriculum
9	adopted under Section 61.822(b):
10	(1) may not:
11	(A) distort a significant historical event;
12	(B) include an aspect that teaches identity
13	politics; or
14	(C) be based on a theory that systemic racism,
15	sexism, oppression, or privilege is inherent in the institutions of
16	the United States or this state or was created to maintain social,
17	political, or economic inequities; and
18	(2) must impart:
19	(A) for a communication course, the ability to
20	communicate effectively, including the ability to write clearly and
21	engage in public speaking;
22	(B) for a mathematics course, an understanding of
23	key mathematical concepts and the application of appropriate
24	quantitative tools to everyday experience;

- (C) for a life and physical science course, the 1 ability to critically examine and evaluate the principles of the 2 scientific method and an understanding of biology, life sciences, 3 anatomy, chemistry, physics, geology, astronomy, or computer 4 5 sciences; 6 (D) for a language course, an ability to speak, 7 read, and write in a foreign language; 8 (E) for a literature or philosophy course, an understanding of the literary or philosophical development of 9 10 Western civilization; (F) for an arts course, an appreciation of and 11 12 ability to analyze visual arts, performing arts, music, or film; (G) for a United States history course, a broad 13 14 understanding of the history of the United States and of this state; 15 (H) for a United States government course, an understanding of civics, including principles of the founding of 16 17 the United States, such as natural rights, liberty, equality, democracy, separation of powers, checks and balances, federalism, 18 constitutional self-government, and the structure, function, and 19 roles of state and local governments; and 20
- 21 (I) for a behavioral and social science course, 22 an understanding of concepts and principles used in the analysis of 23 human behavior and of past and present social, political, and
- 24 <u>economic issues.</u>
- 25 SECTION 2. Section 61.8221, Education Code, as added by 26 this Act, applies beginning with the 2025-2026 academic year.
- 27 SECTION 3. This Act takes effect immediately if it receives

- 1 a vote of two-thirds of all the members elected to each house, as
- 2 provided by Section 39, Article III, Texas Constitution. If this
- 3 Act does not receive the vote necessary for immediate effect, this
- 4 Act takes effect September 1, 2025.
