## A BILL TO BE ENTITLED

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 22.028, Transportation Code, is amended
- 6 to read as follows:
- 7 Sec. 22.028. CONFIDENTIALITY OF CERTAIN INFORMATION
- 8 COLLECTED BY LOCAL GOVERNMENT. Personal identifying information
- 9 collected by a local government is confidential and not subject to
- 10 disclosure under Chapter 552, Government Code, if the information
- 11 collected is in relation to a person's use of an airport [parking]
- 12 facility that includes:
- 13 (1) the person's name, address, e-mail address, phone
- 14 number, and zip code;
- 15 (2) the person's license plate number, toll tag
- 16 number, and credit, debit, or other payment card number; [or]
- 17 (3) the dates the person's vehicle was parked at a
- 18 parking [the] facility, the date the person's vehicle exited the
- 19 parking facility, and the amount the person paid to park in the
- 20 parking facility;
- 21 (4) the person's profile name associated with a
- 22 purchase or other online or in-person activity;
- 23 (5) the person's travel dates and flight information;
- 24 (6) the dates, times, and amounts of any purchase made

- 2 (7) the person's airport lounge memberships and
- 3 <u>trusted traveler information</u>.
- 4 SECTION 2. Section 22.091, Transportation Code, is amended
- 5 to read as follows:
- 6 Sec. 22.091. CONFIDENTIALITY OF CERTAIN INFORMATION
- 7 COLLECTED BY JOINT BOARD. Personal identifying information
- 8 collected by a joint board for which the constituent agencies are
- 9 populous home-rule municipalities is confidential and not subject
- 10 to disclosure under Chapter 552, Government Code, if the
- 11 information collected is in relation to:
- 12 (1) a commercial online payment system and includes a
- 13 person's:
- 14 (A) name, address, e-mail address, or phone
- 15 number;
- 16 (B) account number, password, payment
- 17 transaction activity, toll or charge record, or credit, debit, or
- 18 other payment card number; or
- 19 (C) other personal financial information; or
- 20 (2) a person's use of an airport [parking] facility
- 21 that includes:
- 22 (A) the person's name, address, e-mail address,
- 23 phone number, and zip code;
- 24 (B) the person's license plate number, toll tag
- 25 number, and credit, debit, or other payment card number; [or]
- 26 (C) the dates the person's vehicle was parked at
- 27 a parking [the] facility, the date the person's vehicle exited the

- 3 (D) the person's profile name associated with a

- 5 <u>(E) the person's travel dates and flight</u>

- 7 (F) the dates, times, and amounts of any purchase
- 8 made by the person; or
- 9 (G) the person's airport lounge memberships and
- 10 trusted traveler information.
- 11 SECTION 3. The changes in law made by this Act apply only to
- 12 a request for public information received by a governmental body or
- 13 an officer for public information on or after the effective date of
- 14 this Act.
- 15 SECTION 4. This Act takes effect September 1, 2025.
