Section 351.153(a), Tax Code, is amended to read 11 as follows: 12 This section applies only to a municipality described by 13 (a) 14 Section 351.152(5), (6), (29), [or] (58), or (65). 15 SECTION 3. This Act takes effect immediately if it receives a vote of two-thirds of all the members elected to each house, as 16 provided by Section 39, Article III, Texas Constitution. If this 17 Act does not receive the vote necessary for immediate effect, this 18 Act takes effect September 1, 2025. 19
