A BILL TO BE ENTITLED 1 AN ACT 2 relating to the use of municipal hotel occupancy tax revenue in certain municipalities. 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS: 4 5 SECTION 1. Section 351.101(a), Tax Code, is amended to read as follows: 6 7 (a) Revenue from the municipal hotel occupancy tax may be used only to promote tourism and the convention and hotel industry, 8 9 and that use is limited to the following: (1) the acquisition of sites for and the construction, 10 11 improvement, enlarging, equipping, repairing, operation, and 12 maintenance of convention center facilities or visitor information centers, or both; 13 14 (2) the furnishing of facilities, personnel, and materials for the registration of convention delegates 15 or 16 registrants; (3) 17 advertising and conducting solicitations and promotional programs to attract tourists and convention delegates 18 or registrants to the municipality or its vicinity; 19 20 (4) the encouragement, promotion, improvement, and 21 application of the arts, including instrumental and vocal music, dance, drama, folk art, creative writing, architecture, design and 22 23 allied fields, painting, sculpture, photography, graphic and craft arts, motion pictures, radio, television, tape and sound recording, 24

 and other arts related to the presentation, performance, execution,
 and exhibition of these major art forms;
 (5) historical restoration and preservation projects
 or activities or advertising and conducting solicitations and
 promotional programs to encourage tourists and convention

1 (xi) contains an intersection of 2 Interstates 35E and 35W and at least two public universities; or 3 (xii) is described by Subdivision (6)(C); 4 and

5 (C) the sports facilities and fields have been 6 used, in the preceding calendar year, a combined total of more than 7 10 times for district, state, regional, or national sports 8 tournaments;

9 (8) for a municipality with a population of at least 10 70,000 but less than 90,000, no part of which is located in a county 11 with a population greater than 150,000, the construction, 12 improvement, enlarging, equipping, repairing, operation, and 13 maintenance of a coliseum or multiuse facility;

14 (9) signage directing the public to sights and 15 attractions that are visited frequently by hotel guests in the 16 municipality;

(10) the construction, improvement, enlarging, equipping, repairing, operation, and maintenance of a coliseum or multiuse facility, if the municipality:

(A) has a population of at least 90,000 but less21 than 120,000; and

(B) is located in two counties, at least one ofwhich contains the headwaters of the San Gabriel River; and

(11) for a municipality with a population of more than
175,000 but less than 225,000 that is located in two counties, each
of which has a population of less than 200,000, the construction,
improvement, enlarging, equipping, repairing, operation, and

1 maintenance of a coliseum or multiuse facility and related 2 infrastructure or a venue, as defined by Section 334.001(4), Local 3 Government Code, that is related to the promotion of tourism.

4 SECTION 2. Section 351.1066(a), Tax Code, is amended to 5 read as follows:

(a) This section applies only to:

7 (1) a municipality with a population of at least 3,500 8 but less than 5,500 that is the county seat of a county with a 9 population of less than 50,000 that borders a county with a 10 population of more than 1.6 million;

(2) a municipality with a population of at least 2,800 but less than 3,500 that is the county seat of a county with a population of less than 22,000 that is bordered by the Trinity River and includes a state park and a portion of a wildlife management area;

16 (3) a municipality with a population of at least 8,000
17 that is located in a county that borders the Pecos River and that
18 has a population of not more than 15,000;

(4) a municipality with a population of not more than 20 15,000 that is located in a county through which the Frio River 21 flows and an interstate highway crosses, and that has a population 22 of at least 15,000;

(5) a municipality with a population of not less than
7,500 that is located in a county with a population of not less than
40,000 but less than 250,000 that is adjacent to a county with a
population of less than 750;

with a population of at least 8,500 and that county contains part of
 the Chaparral Wildlife Management Area; [and]

3 (7) a municipality that has a population of not more 4 than 25,000, that contains a cultural heritage museum, and that is 5 located in a county that borders the United Mexican States and the 6 Gulf of Mexico<u>; and</u>

7 (8) a municipality that has a population of at least 8 19,000 and is wholly located in a county in which the State Capitol 9 is located.

10 SECTION 3. This Act takes effect immediately if it receives 11 a vote of two-thirds of all the members elected to each house, as 12 provided by Section 39, Article III, Texas Constitution. If this 13 Act does not receive the vote necessary for immediate effect, this 14 Act takes effect September 1, 2025.
