1-22 A BILL TO BE ENTITLED  
1-23 AN ACT

1-24 relating to the election of certain entities to participate in the  
1-25 uniform group coverage program for active school employees;  
1-26 imposing a fee.

1-27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-28 SECTION 1. Subchapter D, Chapter 1579, Insurance Code, is  
1-29 amended by adding Section 1579.1551 to read as follows:

1-30 Sec. 1579.1551. PROGRAM PARTICIPATION BY CERTAIN ENTITIES.

1-31 (a) This section applies to an entity that discontinued  
1-32 participation in the program effective on September 1, 2022, in  
1-33 accordance with Section 1579.155(a).

1-34 (b) Notwithstanding Section 1579.155(b), an entity to which  
1-35 this section applies may elect to participate in the program before  
1-36 the fifth anniversary of the effective date of the entity's  
1-37 election to discontinue participation in the program if the entity:

1-38 (1) provides written notice to the trustee not later  
1-39 than December 31, 2025, of the entity's election to participate in  
1-40 the program effective beginning September 1, 2026; and

1-41 (2) complies with any other requirements established  
1-42 by the trustee for program participation.

1-43 (c) For the plan year beginning September 1, 2026, the  
1-44 trustee shall impose a risk stabilization fee in an amount  
1-45 determined by the trustee on the premiums of an entity to which this  
1-46 section applies.

1-47 (d) An entity that elects to participate in the program in  
1-48 accordance with this section may not elect to discontinue  
1-49 participation until September 1, 2031.

1-50 (e) The trustee by rule may impose additional requirements,  
1-51 conditions, and deadlines with which an entity to which this  
1-52 section applies must comply to elect to participate in the program  
1-53 in accordance with this section.

1-54 (f) This section expires September 1, 2031.

1-55 SECTION 2. This Act takes effect September 1, 2025.
