4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter D, Chapter 32, Penal Code, is amended
6	by adding Section 32.56 to read as follows:
7	Sec. 32.56. FRAUDULENT USE OR POSSESSION OF GIFT CARD OR
8	GIFT CARD REDEMPTION INFORMATION. (a) In this section:
9	(1) "Cardholder" means a person to whom a physical or
10	virtual gift card is given or any person who purchased the gift
11	card.
12	(2) "Card issuer" means any person that issues a gift
13	card or the agent of that person with respect to the card.
14	(3) "Gift card" means a card, code, or device that is
15	issued to a consumer on a prepaid basis in a specified amount and
16	redeemable upon presentation for the purchase of goods or services
17	and that is either activated or inactivated.
18	(4) "Gift card redemption information" means
19	information unique to each gift card that allows the cardholder to
20	access, transfer, or spend funds on the gift card.
21	(5) "Gift card seller" means a merchant engaged in the
22	business of selling gift cards to consumers.
23	(b) A person commits an offense if the person, with the
24	intent to harm or defraud another:

1	(1) acquires or retains possession of a gift card or
2	gift card redemption information without the consent of the
3	cardholder, card issuer, or gift card seller;
4	(2) alters or tampers with a gift card; or
5	(3) uses or attempts to use a gift card or gift card
6	redemption information to obtain goods, services, or anything else
7	of value with knowledge that the gift card or gift card redemption
8	information has been obtained in violation of Subdivision (1) or
9	altered or tampered with.
10	(c) An offense under this section is:
11	(1) a Class C misdemeanor if the value of the gift
12	card, gift cards, or gift card redemption information involved is
13	less than \$100;
14	(2) a Class B misdemeanor if the value of the gift
15	card, gift cards, or gift card redemption information involved is
16	\$100 or more but less than \$750;
17	(3) a Class A misdemeanor if the value of the gift
18	card, gift cards, or gift card redemption information involved is
19	\$750 or more but less than \$2,500;
20	(4) a state jail felony if the value of the gift card,
21	gift cards, or gift card redemption information involved is \$2,500
22	or more but less than \$30,000;
23	(5) a felony of the third degree if the value of the
24	gift card, gift cards, or gift card redemption information involved
25	<u>is \$30,000 or more but less than \$150,000;</u>
26	(6) a felony of the second degree if the value of the
27	gift card, gift cards, or gift card redemption information involved

1	is \$150,000 or more but less than \$300,000; and
2	(7) a felony of the first degree if the value of the
3	gift card, gift cards, or gift card redemption information involved
4	<u>is \$300,000 or more.</u>
5	SECTION 2. This Act takes effect September 1, 2025.
