- 2 supervision and suspend commitment if the court finds that the
- 3 respondent:
- 4 (1) is in contempt of court for the failure or refusal
- 5 to obey an order for possession of or access to a child; and

- 7 <u>least three times for the failure or refusal to obey an order for</u>

- 10 (d) If the court finds that the person denying possession or
- 11 access has previously been found in contempt of court at least three
- 12 times for the denial of court-ordered possession or access with
- 13 respect to the child who is the subject of the proceeding, the
- 14 additional periods of possession of or access to the child ordered
- 15 by the court under this section must be, in total, twice the
- 16 <u>duration of the periods of possession and access that were denied.</u>
- SECTION 5. Sections 157.168(a-1) and (c), Family Code, are
- 18 repealed.
- 19 SECTION 6. (a) Section 156.107, Family Code, as added by
- 20 this Act, applies to a suit for modification that is pending in a
- 21 trial court on the effective date of this Act or that is filed on or
- 22 after that date.
- 23 (b) The changes in law made by this Act to Sections 157.165
- 24 and 157.168, Family Code, apply to a suit affecting the
- 25 parent-child relationship that is pending in a trial court on the
- 26 effective date of this Act or that is filed on or after the
- 27 effective date of this Act.

- 1 (c) The change in law made by this Act to Section 157.167,
- 2 Family Code, applies only to an enforcement order rendered on or
- 3 after the effective date of this Act. An enforcement order rendered
- 4 before the effective date of this Act is governed by the law in
- 5 effect on the date the order was rendered, and the former law is
- 6 continued in effect for that purpose.
- 7 SECTION 7. This Act takes effect September 1, 2025.
