14	of Texas house of representatives building housed on the first
15	capitol site.
16	Sec. 442.0681. JURISDICTION AND MAINTENANCE OF FIRST
17	CAPITOL SITE AND REPLICA. (a) The first capitol site and replica
18	are under the jurisdiction of the commission. The commission is
19	responsible for the preservation, maintenance, and operation of the
20	site and replica.
21	(b) The commission shall:
22	(1) develop, expand, and manage the first capitol site
23	and replica by:
24	(A) expanding, renovating, and managing the site

8	(7) facilitate community engagement and partnership
9	for the first capitol site and replica by:
10	(A) collaborating with local organizations,
11	schools, and other relevant stakeholders to foster community
12	involvement and support of the site;
13	(B) establishing partnerships with historical
14	societies, institutions of higher education, and cultural
15	organizations to strengthen the site's educational impact; and
16	(C) hosting events, lectures, and programs that
17	encourage public participation and awareness of this state's
18	history; and
19	(8) ensure responsible stewardship of resources and
20	the first capitol site and replica by:
21	(A) maintaining ethical and professional
22	standards for site operations; and
23	(B) conducting periodic assessments to measure
24	progress and identify areas to improve stewardship of the site.

26	accept a grant or donation for any program or purpose of the first
27	capitol site and replica.
