4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Chapter 556, Government Code, is amended by
6	adding Section 556.0056 to read as follows:
7	Sec. 556.0056. RESTRICTION ON USE OF PUBLIC FUNDS BY
8	POLITICAL SUBDIVISIONS FOR LOBBYING ACTIVITIES. (a) A political
9	subdivision may not spend public funds:
10	(1) to hire an individual required to register as a
11	lobbyist under Chapter 305 for the purpose of lobbying a member of
12	the legislature; or
13	(2) to pay a nonprofit state association or
14	organization that:
15	(A) primarily represents political subdivisions;
16	and
17	(B) hires or contracts with an individual
18	required to register as a lobbyist under Chapter 305.
19	(b) Subsection (a) does not prohibit:
20	(1) an officer or employee of a political subdivision
21	from providing information for a member of the legislature or
22	appearing before a legislative committee;
23	(2) an elected officer of a political subdivision from
24	advocating for or against or otherwise influencing or attempting to

No. 3257 1 influence the outcome of legislation pending before the legislature 2 while acting as an officer of the political subdivision; (3) an employee of a political subdivision from 3 advocating for or against or otherwise influencing or attempting to 4 5 influence the outcome of legislation pending before the legislature if those actions would not require a person to register as a 6 lobbyist under Chapter 305; 7 8 (4) a political subdivision from reimbursing an officer or full-time employee of the political subdivision for 9 direct travel expenses incurred by the officer or employee for 10 11 engaging in an activity described by Subdivision (1), (2), or (3); 12 or (5) a full-time employee of a nonprofit state 13 association or organization that primarily represents political 14 15 subdivisions of this state from: 16 (A) providing legislative services related to 17 bill tracking, bill analysis, and legislative alerts; (B) communicating directly with a member of the 18 19 legislature to provide information if the communication would not require a person to register as a lobbyist under Chapter 305; or 20 21 (C) testifying for or against legislation before 22 the legislature. (c) If a political subdivision engages in an activity 23 24 prohibited by Subsection (a), a taxpayer or resident of the political subdivision is entitled to appropriate injunctive relief 25 26 to prevent further activity prohibited by that subsection and further payment of public funds related to that activity. 27

(d) A taxpayer or resident who prevails in an action under 1 Subsection (c) is entitled to recover from the political 2 subdivision the taxpayer's or resident's reasonable attorney's fees 3 and costs incurred in bringing the action. 4 SECTION 2. Section 89.002, Local Government 5 Code, is 6 amended to read as follows: Sec. 89.002. STATE ASSOCIATION OF COUNTIES. (a) Except as 7 provided by Section 556.0056, Government Code, the 8 [The] commissioners court may spend, in the name of the county, money from 9 the county's general fund for membership fees and dues of a 10 nonprofit state association of counties if: 11 (1) a majority of the court votes to 12 approve membership in the association; 13 (2) the association exists for the betterment of 14 15 county government and the benefit of all county officials; 16 (3) the association is not affiliated with a labor 17 organization; and [neither the association nor an employee of the (4)18 association directly or indirectly influences or attempts to 19 influence the outcome of any legislation pending before the 20 legislature, except that this subdivision does not prevent a person 21 from providing information for a member of the legislature or 22 appearing before a legislative committee at the request of the 23 24 committee or the member of the legislature; and 25 [(5)] neither the association nor an employee of the association directly or indirectly contributes any money, 26 services, or other valuable thing to a political campaign or 27

1 endorses a candidate or group of candidates for public office.

(b) If any association or organization supported wholly or partly by payments of tax receipts from political subdivisions engages in an activity described by Subsection (a)(4) [or (5)], a taxpayer of a political subdivision that pays fees or dues to the association or organization is entitled to appropriate injunctive relief to prevent any further activity described by Subsection (a)(4) [or (5)] or any further payments of fees or dues.

9 SECTION 3. Section 556.0056, Government Code, as added by 10 this Act, applies only to an expenditure or payment of public funds by a political subdivision that is made on or after the effective 11 12 date of this Act, including an expenditure or payment of public funds by a political subdivision that is made under a contract 13 14 entered into before, on, or after the effective date of this Act. A 15 contract term providing for an expenditure or payment prohibited by Section 556.0056, Government Code, as added by this Act, is void on 16 17 the effective date of this Act.

SECTION 4. Section 89.002, Local Government Code, 18 as 19 amended by this Act, applies only to the spending of money by a county from the county's general fund that occurs on or after the 20 21 effective date of this Act. The spending of money by a county from the county's general fund that occurs before the effective date of 22 23 this Act is governed by the law as it existed immediately before the 24 effective date of this Act, and that law is continued in effect for 25 that purpose.

SECTION 5. This Act takes effect September 1, 2025.
