9	SECTION 2. The	e change in law made by this Act does not

10 affect tax liability accruing before the effective date of this 11 Act. That liability continues in effect as if this Act had not been 12 enacted, and the former law is continued in effect for the 13 collection of taxes due and for civil and criminal enforcement of 14 the liability for those taxes.

15 SECTION 3. This Act takes effect immediately if it receives 16 a vote of two-thirds of all the members elected to each house, as 17 provided by Section 39, Article III, Texas Constitution. If this 18 Act does not receive the vote necessary for immediate effect, this 19 Act takes effect September 1, 2025.
