Section 453.003(a), Estates Code, is amended to

No. 3421 read as follows: 1 (a) If there is no qualified executor or administrator of a 2 3 deceased spouse's estate, the surviving spouse, as the surviving partner of the marital partnership, may: 4 5 (1)sue and be sued to recover community property; 6 (2) sell, mortgage, lease, and otherwise dispose of 7 community property to pay [community] debts  $[\tau]$  for which a portion of community property is liable for payment; 8 9 (3) collect claims due to the community estate; and 10 (4) exercise other powers as necessary to: 11 (A) preserve the community property; 12 (B) discharge [community] obligations  $[\tau]$  for which a portion of community property is liable for payment; and 13 14 (C) wind up community affairs. 15 SECTION 9. SECTION 12. Section 33.105, Estates Code, as amended by
this Act, applies to a proceeding that is pending or commenced on or
after the effective date of this Act.

4 SECTION 13. Section 256.202, Estates Code, as amended by 5 this Act, applies only to a proceeding commenced on or after the 6 effective date of this Act. A proceeding commenced before the 7 effective date of this Act is governed by the law in effect on the 8 date the proceeding was commenced, and the former law is continued 9 in effect for that purpose.

10 SECTION 14. Sections 309.051(a) and 309.052, Estates Code, 11 as amended by this Act, apply to the administration of the estate of 12 a decedent that is pending or commenced on or after the effective 13 date of this Act.

SECTION 15. Section 452.006(c), Estates Code, as amended by this Act, applies only to a temporary administrator appointed on or after the effective date of this Act. A temporary administrator appointed before the effective date of this Act is governed by the law in effect on the date the administrator was appointed, and the former law is continued in effect for that purpose.

20 SECTION 16. This Act takes effect September 1, 2025.
