4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Subchapter B, Chapter 7, Education Code, is
6	amended by adding Section 7.038 to read as follows:
7	Sec. 7.038. COLLECTION AND REPORTING OF CERTAIN DEMOGRAPHIC
8	INFORMATION. (a) In collecting and disaggregating data by race or
9	ethnicity for purposes of a reporting requirement related to
10	academic achievement, graduation rates, attendance rates,
11	languages spoken at home, or access to educational resources, the
12	agency shall require the following categories to be used:
13	(1) American Indian or Alaska Native, including
14	subcategories including all Indian tribes or bands which are
15	recognized by federal law and located in this state;
16	(2) Asian, including the following subcategories:
17	(A) Asian Indian;
18	(B) Chinese;
19	(C) Filipino;

21	(E) Pakistani;

- 9 SECTION 2. Not later than the 2027-2028 school year, the
- 10 Texas Education Agency shall revise the agency's reporting
- 11 standards as necessary to comply with Section 7.038, Education
- 12 Code, as added by this Act.
- SECTION 3. This Act takes effect September 1, 2025.
