10	(3) "Beneficiary" means a retiree, or the spouse or
11	other eligible dependent of a retiree, who is entitled to receive
12	retiree health benefits under Section $5.01 (5.01(a))$ of this Act.
13	(4-a) "Default rate" means the actuarial assumed rate
14	of return as determined by the fund's actuary.
15	(6-b-1) "Months of service" means the number of full
16	months of service beginning on the date the firefighter or police
17	officer becomes a member of the fund until the date the firefighter

- 1. 16 17 officer becomes a member of the fund until the date the firefighter or police officer retires or otherwise terminates employment as a 18 firefighter or police officer, less the number of full months of 19 service during which the member: 20
- 21 (A) was engaged in active service with any uniformed service of the United States and did not purchase credit 22 for that service in accordance with Section 4.023 of this Act; 23 24 (B) took other unpaid leave, including unpaid

- 1 leave described by Section 4.024 of this Act, and did not purchase
- 2 credit for that leave in accordance with applicable law; or
- 3 (C) was placed on unpaid leave by the
- 4 municipality to which this Act applies.
- 5 (8) "Retiree" means an individual who was a
- 6 firefighter or police officer who retired under the pension act
- 7 [whose retirement date is] after September 30, 1989.
- 8 (8-a) "Retiree health plan" means the group family
- 9 health plan for retirees and other beneficiaries:
- 10 <u>(A)</u> established under this Act; and
- 11 (B) in effect on October 1, 2025 [by the
- 12 collective bargaining agreements and the master contract
- 13 document].
- 14 SECTION 2. Section 1.05, Chapter 1332 (S.B. 1568), Acts of
- 15 the 75th Legislature, Regular Session, 1997 (Article 6243q,
- 16 Vernon's Texas Civil Statutes), is amended to read as follows:
- 17 Sec. 1.05. EXEMPTIONS. (a) The health benefits paid or
- 18 payable by the fund are exempt from garnishment, assignment,
- 19 attachment, judgments, other legal processes, and inheritance or
- 20 other taxes established by this state.
- 21 (b) Fund assets are exempt from attachment, execution,
- 22 alienation, and forced sale. A judgment lien or abstract of
- 23 judgment may not be filed or perfected against the fund on fund
- 24 assets. A judgment lien or abstract of judgment filed against the
- 25 fund on fund assets is void.
- SECTION 3. Article 1, Chapter 1332 (S.B. 1568), Acts of the

- 14 (2) two members of the [municipal] governing body of
- 15 the municipality to which this Act applies, appointed by that
