1-18 A BILL TO BE ENTITLED  
1-19 AN ACT

1-20 relating to assistance in the investigation of certain open  
1-21 meetings offenses by the open records division of the attorney  
1-22 general's office.

1-23 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:

1-24 SECTION 1. Subchapter B, Chapter 2A, Code of Criminal  
1-25 Procedure, is amended by adding Article 2A.067 to read as follows:

1-26 Art. 2A.067. PROVISION OF CERTAIN INFORMATION TO ATTORNEY  
1-27 GENERAL. (a) A law enforcement agency that submits to the office  
1-28 of a district attorney, criminal district attorney, or county  
1-29 attorney a report stating there is probable cause to believe an  
1-30 identified person has committed a criminal offense under Chapter  
1-31 551, Government Code, shall simultaneously submit a copy of that  
1-32 report to the open records division of the attorney general's  
1-33 office.

1-34 (b) On request of the attorney general, a law enforcement  
1-35 agency shall provide all requested information that has not been  
1-36 made publicly available regarding an investigation of an offense  
1-37 under Chapter 551, Government Code, to the open records division of  
1-38 the attorney general's office.

1-39 SECTION 2. Subchapter C, Chapter 2A, Code of Criminal  
1-40 Procedure, is amended by adding Article 2A.112 to read as follows:

1-41 Art. 2A.112. INVESTIGATION OF OPEN MEETING OFFENSES. (a)  
1-42 An attorney representing the state in the prosecution of a criminal  
1-43 offense under Chapter 551, Government Code, may request the  
1-44 assistance of the open records division of the attorney general's  
1-45 office in the investigation of the offense.

1-46 (b) On request of the attorney general, the attorney  
1-47 representing the state in the prosecution of a criminal offense  
1-48 under Chapter 551, Government Code, shall provide to the open  
1-49 records division of the attorney general's office all requested  
1-50 information that has not been made publicly available regarding the  
1-51 investigation of the offense.

1-52 SECTION 3. Subchapter B, Chapter 402, Government Code, is  
1-53 amended by adding Section 402.02801 to read as follows:

1-54 Sec. 402.02801. INVESTIGATION OF OPEN MEETING OFFENSES.

1-55 (a) The open records division of the attorney general's office, on  
1-56 the request of a law enforcement agency under Article 2A.067, Code  
1-57 of Criminal Procedure, or an attorney representing the state under  
1-58 Article 2A.112, Code of Criminal Procedure, may assist the agency  
1-59 or attorney in the investigation of a criminal offense under  
1-60 Chapter 551.
