4	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
5	SECTION 1. Section 151.316(a), Tax Code, is amended to read
6	as follows:

- 7 (a) Subject to Section 151.1551, the following items are 8 exempted from the taxes imposed by this chapter:
- 9 (1) horses, mules, and work animals;
- 10 (2) animal life the products of which ordinarily 11 constitute food for human consumption;

- 11 SECTION 2. The change in law made by this Act does not
- 12 affect tax liability accruing before the effective date of this
- 13 Act. That liability continues in effect as if this Act had not been
- 14 enacted, and the former law is continued in effect for the
- 15 collection of taxes due and for civil and criminal enforcement of
- 16 the liability for those taxes.
- 17 SECTION 3. This Act takes effect September 1, 2025.
