17	(b) The council is administratively attached to the		
18	department. The department shall provide administrative support to		
19	the council.		
20	Sec. 104A.003. MEMBERSHIP. (a) The council is composed of:		
21	(1) at least one representative appointed by the		
22	executive director or governing body of each of the following:		
23	(A) the department;

- Sec. 104A.006. WORK GROUP. (a) The council shall establish

- 1 a work group to examine the health professions and health care
- 2 education programs that provide a gateway into a variety of health
- 3 professions. The work group consists of members of the council or

- 6 (1) identify sources for gathering information on

- Sec. 104A.007. NURSING ADVISORY COMMITTEE. (a) The
