No. 3966 date an owner or operator of a commercial passenger bus service 1 2 begins operating a new terminal located in this state, the owner or operator shall provide notice of the proposed terminal to the 3 community in which the terminal is to be located as prescribed by 4 5 Subsection (b). 6 (b) The notice required by this section must: 7 (1) be published in a newspaper of general circulation 8 in the municipality: 9 (A) in which the proposed terminal is to be 10 located; or (B) nearest to the proposed location of the 11 12 terminal; and (2) except as provided by Subsection (c), if the 13 14 elementary or middle school nearest to the proposed location of the 15 terminal provides a bilingual education program as required by Subchapter B, Chapter 29, Education Code, be published by the owner 16 17 or operator at least once in an additional publication of general circulation in the municipality or county in which the terminal is 18 19 proposed to be located that is published in the language taught in the bilingual education program. 20 21 (c) An owner or operator of a commercial bus service does 22 not have to comply with the requirements of Subsection (b)(2) if: (1) a publication described by that subdivision does 23 24 not exist; or 25 (2) the publisher of a publication that meets the 26 requirements of that subdivision refuses to publish notice. 27 (d) An owner or operator of a commercial passenger bus
