## A BILL TO BE ENTITLED

AN ACT

- 2 relating to the regulation of art therapy, including the
- 3 establishment of the Texas Art Therapy Board and the duties of the
- 4 Texas Behavioral Health Executive Council; requiring an
- 5 occupational license; creating a criminal offense; imposing a fee.
- 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 7 ARTICLE 1. TEXAS BEHAVIORAL HEALTH EXECUTIVE COUNCIL
- 8 SECTION 1.01. Section 507.001, Occupations Code, is amended
- 9 by amending Subdivision (1) and adding Subdivision (1-a) to read as
- 10 follows:
- 11 (1) "Art therapy board" means the Texas Art Therapy
- 12 Board established under Chapter 508.
- 13 <u>(1-a)</u> "Executive council" means the Texas Behavioral
- 14 Health Executive Council.
- SECTION 1.02. Section 507.051(a), Occupations Code, is
- 16 amended to read as follows:
- 17 (a) The Texas Behavioral Health Executive Council consists
- 18 of <u>eleven</u> [ $\frac{\text{nine}}{\text{nine}}$ ] members as follows:
- 19 (1) one marriage and family therapist member and one
- 20 public member of the marriage and family therapy board, each
- 21 appointed by that board;
- 22 (2) one licensed professional counselor member and one
- 23 public member of the professional counseling board, each appointed
- 24 by that board;

- 1 (3) one psychologist member and one public member of
- 2 the psychology board, each appointed by that board;
- 3 (4) one social worker member and one public member of
- 4 the social work board, each appointed by that board; [and]
- 5 (5) one professional art therapist member and the
- 6 public member of the art therapy board, each appointed by that
- 7 board; and
- 8 (6) one public member appointed by the governor.
- 9 SECTION 1.03. Section 507.052, Occupations Code, is amended
- 10 to read as follows:
- 11 Sec. 507.052. ELIGIBILITY OF PUBLIC MEMBER APPOINTED BY
- 12 GOVERNOR. A person is not eligible for appointment by the governor
- 13 as a public member of the executive council if the person or the
- 14 person's spouse:
- 15 (1) is registered, certified, or licensed by an
- 16 occupational regulatory agency in the field of health care;
- 17 (2) is employed by or participates in the management
- 18 of a business entity or other organization regulated by or
- 19 receiving money from the executive council, the marriage and family
- 20 therapy board, the professional counseling board, the psychology
- 21 board, [or the social work board, or the art therapy board;
- 22 (3) owns or controls, directly or indirectly, more
- 23 than a 10 percent interest in a business entity or other
- 24 organization regulated by or receiving money from the executive
- 25 council, the marriage and family therapy board, the professional
- 26 counseling board, the psychology board, [or] the social work board,
- 27 or the art therapy board; or

- (4) uses or receives a substantial amount of tangible goods, services, or money from the executive council, the marriage and family therapy board, the professional counseling board, the psychology board, [ex] the social work board, or the art therapy board, other than compensation or reimbursement authorized by law for executive council, marriage and family therapy board, professional counseling board, psychology board, [ex] social work
- 9 SECTION 1.04. Section 507.053(c), Occupations Code, is 10 amended to read as follows:

- (c) A person may not be a member of the executive council or 11 12 act as the general counsel to the executive council if the person is required to register as a lobbyist under Chapter 305, Government 13 14 Code, because of the person's activities for compensation on behalf 15 of a profession related to the operation of the executive council, the marriage and family therapy board, the professional counseling 16 17 board, the psychology board, [or the social work board, or the art 18 therapy board.
- 19 SECTION 1.05. Section 507.151(a), Occupations Code, is 20 amended to read as follows:
- 21 (a) The executive council shall administer and enforce this 22 chapter and Chapters 501, 502, 503, [and] 505, and 508.
- 23 SECTION 1.06. Section 507.153(a), Occupations Code, is 24 amended to read as follows:
- 25 (a) Unless the rule has been proposed by the applicable 26 board for the profession, the executive council may not adopt under 27 this chapter or Chapter 501, 502, 503, [ex.] 505, or 508:

1	(1) a rule regarding:
2	(A) the qualifications necessary to obtain a
3	license, including limiting an applicant's eligibility for a
4	license based on the applicant's criminal history;
5	(B) the scope of practice of and standards of
6	care and ethical practice for the profession; or
7	(C) continuing education requirements for
8	license holders; or
9	(2) a schedule of sanctions for violations of the laws
10	and rules applicable to the profession.
11	SECTION 1.07. Section 507.154, Occupations Code, is amended
12	to read as follows:
13	Sec. 507.154. FEES. The executive council shall set fees in
14	amounts reasonable and necessary to cover the costs of
15	administering this chapter and Chapters 501, 502, 503, [and] 505,
16	and 508, including fees for:
17	(1) licenses issued by the executive council;
18	(2) license renewals and late renewals;
19	(3) examinations; and
20	(4) any other program or activity administered by the
21	executive council for which a fee is authorized.
22	ARTICLE 2. ART THERAPISTS
23	SECTION 2.01. Subtitle I, Title 3, Occupations Code, is
24	amended by adding Chapter 508 to read as follows:
25	CHAPTER 508. ART THERAPISTS
26	SUBCHAPTER A. GENERAL PROVISIONS
27	Sec. 508.001. SHORT TITLE. This chapter may be cited as the

1	"Art Therapy Licensing and Practice Act."
2	Sec. 508.002. DEFINITIONS. In this chapter:
3	(1) "Accredited educational institution" means:
4	(A) a university or college accredited by the
5	Commission on Accreditation of Allied Health Education Programs or
6	another nationally recognized accrediting agency of institutions
7	of higher education approved by the executive council; or
8	(B) an institution and clinical program approved
9	by the American Art Therapy Association, or a successor
10	organization approved by the executive council.
11	(2) "Board" means the Texas Art Therapy Board.
12	(3) "Executive council" means the Texas Behavioral
13	Health Executive Council.
14	(4) "Face-to-face meeting" means:
15	(A) an in-person meeting between two or more
16	persons; or
17	(B) a video meeting between two or more persons,
18	if the meeting is synchronous and involves verbal and visual
19	<u>interaction.</u>
20	(5) "Licensed associate art therapist" means a person
21	who holds an associate art therapist license issued under this
22	<pre>chapter.</pre>
23	(6) "Licensed professional art therapist" means a
24	person who holds a professional art therapist license issued under
25	this chapter.
26	(7) "Qualified art therapy supervisor" means any
27	person who:

1	(A) is a licensed professional art therapist; or
2	(B) both:
3	(i) is a licensed professional counselor,
4	licensed clinical social worker, licensed psychologist, licensed
5	marriage and family therapist, or licensed physician; and
6	(ii) holds a credential as a Registered Art
7	Therapist with Board Certification (ATR-BC) or Art Therapy
8	Credentialed Supervisor (ATCS) issued by the Art Therapy
9	Credentials Board, Inc.
10	(8) "Supervised educational experience" means the
11	regular oversight of the functions and activities of a graduate art
12	therapy student by a qualified art therapy supervisor as part of
13	either:
14	(A) an internship or practicum experience; or
15	(B) the practice of art therapy to fulfill the
16	requirements to be licensed under this chapter.
17	(9) "Supervision" means a formalized professional
18	relationship between a qualified art therapy supervisor and a
19	supervised person in which the qualified art therapy supervisor
20	directs, monitors, and evaluates the supervised person's
21	professional art therapy practice while promoting the development
22	of the supervised person's knowledge, skills, and abilities to
23	provide professional art therapy services in an ethical and
24	competent manner.
25	Sec. 508.003. PRACTICE OF ART THERAPY. A person practices
26	art therapy if the person provides, for compensation, a specialized
27	form of psychotherapy that involves expressive arts media and the

- 1 creative process to address and alleviate mental and emotional
- 2 disorders or psychopathologies, improve cognitive function or
- 3 sensory-motor functions, or support wellness, through diagnosis,
- 4 assessment, testing, treatment, evaluation, or rehabilitation.
- 5 The practice of art therapy includes:
- 6 (1) an evidence-based clinical practice of art therapy
- 7 within a professional relationship conducted by a professionally
- 8 trained art therapist who is licensed under this chapter;
- 9 (2) the integration of psychological theories, art
- 10 therapy theory, art-based assessment models, traditional verbal
- 11 counseling techniques, and the creative process into the provision
- 12 of psychotherapy;
- 13 (3) the provision of services to accomplish art
- 14 therapy goals, including using expressive arts media, creative
- 15 techniques, nonverbal communication, psychotherapy, art-based
- 16 assessment models, and the creative process in a therapeutic
- 17 relationship between a client and a licensed professional art
- 18 therapist or a licensed art therapy associate;
- 19 (4) evaluation, assessment, and diagnosis to define
- 20 and implement individualized treatment plans to address
- 21 developmental, rehabilitative, habilitative, medical, mental
- 22 health, preventive, wellness care, or educational needs of clients;
- 23 (5) systematically evaluating and comparing a client's
- 24 response to an individualized art therapy treatment plan and
- 25 <u>suggesting modifications</u>, as appropriate;
- 26 (6) therapeutic interventions to facilitate
- 27 alternative modes of receptive and expressive communication that

1	can circumvent the limitations of verbal articulation;
2	(7) the use of treatment interventions that include
3	psychotherapy or counseling integrated with art therapy theory, the
4	creative process, or art media to facilitate human development and
5	to identify and remediate mental, emotional, or behavioral
6	disorders and associated distresses that interfere with daily
7	functioning; and
8	(8) the use of appropriate knowledge and specialized
9	training in art therapy theory, art media, the creative process,
10	the neurobiological implications of art-making, psychotherapy and
11	counseling principles and theory, and clinical decision-making
12	skills to inform practice and determine the appropriate course of
13	action, tailored to the context of each specific clinical setting.
14	Sec. 508.004. APPLICABILITY. (a) This chapter does not
15	apply to:
16	(1) a student or intern who:
17	(A) practices under the supervision of a
18	qualified art therapy supervisor in an educational institution or
19	agency as part of the institution's or agency's graduate degree
20	program in art therapy or a related field; and
21	(B) is designated by a title such as "student,"
22	"trainee," "intern," or another title clearly indicating the
23	<pre>person's training status; or</pre>
24	(2) an activity conducted or a service performed by a
25	person who is licensed, certified, or registered in a profession
26	other than art therapy, if:
27	(A) the activity or service is conducted or

- 1 performed within the scope of the person's license, certificate, or
- 2 registration; and
- 3 (B) the person does not represent the person to
- 4 the public by any title, initials, or description of services as
- 5 being a licensed professional art therapist or a licensed associate
- 6 art therapist.
- 7 (b) The executive council may adopt rules governing the
- 8 supervision required to qualify for the exemption under Subsection
- 9 (a).
- 10 <u>SUBCHAPTER B. TEXAS ART THERAPY BOARD</u>
- Sec. 508.051. BOARD; MEMBERSHIP. (a) The Texas Art Therapy
- 12 Board consists of five members appointed by the governor with the
- 13 advice and consent of the senate as follows:
- 14 (1) three licensed professional art therapists who
- 15 have been actively engaged in the practice of art therapy in this
- 16 state for at least the three years preceding the member's
- 17 appointment;
- 18 (2) one health care professional who is not a licensed
- 19 professional art therapist; and
- 20 (3) one member who represents the public.
- 21 (b) Appointments to the board shall be made without regard
- 22 to the race, color, disability, sex, religion, age, or national
- 23 origin of the appointee.
- (c) Notwithstanding Subsection (a)(1), a person practicing
- 25 as a professional art therapist is eligible for appointment as an
- 26 initial member of the board regardless of whether the person holds a
- 27 professional art therapy license issued under this chapter. This

- 1 <u>subsection expires September 1, 2026.</u>
- 2 Sec. 508.052. PUBLIC MEMBERSHIP ELIGIBILITY. (a) The
- 3 public member of the board may not:
- 4 (1) be licensed under this chapter; or
- 5 (2) have an interest in the practice of art therapy
- 6 other than as a consumer.
- 7 (b) A person is not eligible for appointment as the public
- 8 member of the board if:
- 9 (1) the person is registered, certified, or licensed
- 10 by an occupational regulatory agency in the field of health care;
- 11 (2) the person's spouse is registered, certified, or
- 12 licensed by an occupational regulatory agency in the field of
- 13 mental health; or
- 14 (3) the person or the person's spouse:
- 15 (A) is employed by or participates in the
- 16 management of a business entity or other organization regulated by
- 17 or receiving funds from the board or executive council;
- (B) owns or controls, directly or indirectly,
- 19 more than a 10 percent interest in a business entity or other
- 20 organization regulated by or receiving funds from the board or
- 21 <u>executive council; or</u>
- (C) uses or receives a substantial amount of
- 23 tangible goods, services, or funds from the board or executive
- 24 council, other than compensation or reimbursement authorized by law
- 25 for board membership, attendance, or expenses.
- Sec. 508.053. MEMBERSHIP RESTRICTIONS. (a) In this
- 27 section, "Texas trade association" means a cooperative and

- 1 voluntarily joined statewide association of business or
- 2 professional competitors in this state designed to assist its
- 3 members and its industry or profession in dealing with mutual
- 4 business or professional problems and in promoting their common
- 5 interest.
- 6 (b) A person may not be a member of the board if:
- 7 (1) the person is an officer, employee, or paid
- 8 consultant of a Texas trade association in the field of health care;
- 9 or
- 10 (2) the person's spouse is an officer, manager, or paid
- 11 consultant of a Texas trade association in the field of mental
- 12 health.
- 13 (c) A person may not be a member of the board if the person
- 14 is required to register as a lobbyist under Chapter 305, Government
- 15 Code, because of the person's activities for compensation on behalf
- of a profession related to the operation of the board.
- Sec. 508.054. TERMS. Members of the board serve staggered
- 18 six-year terms with the terms of one or two members expiring on
- 19 February 1 of each odd-numbered year.
- Sec. 508.055. GROUNDS FOR REMOVAL. (a) It is a ground for
- 21 removal from the board that a member:
- (1) does not have at the time of taking office the
- 23 qualifications required by Section 508.051(a);
- 24 (2) does not maintain during service on the board the
- 25 qualifications required by Section 508.051(a);
- 26 (3) is ineligible for membership under Section 508.052
- 27 <u>or 508</u>.053;

- 1 (4) cannot, because of illness or disability,
- 2 discharge the member's duties for a substantial part of the member's
- 3 term; or
- 4 (5) is absent from more than half of the regularly
- 5 scheduled board meetings that the member is eligible to attend
- 6 during a calendar year without an excuse approved by a majority vote
- 7 of the board.
- 8 (b) The validity of an action of the board is not affected by
- 9 the fact that it is taken when a ground for removal of a board member
- 10 <u>exists.</u>
- 11 (c) If the executive director of the executive council has
- 12 knowledge that a potential ground for removal exists, the executive
- 13 director shall notify the presiding officer of the board of the
- 14 potential ground. The presiding officer shall then notify the
- 15 governor and the attorney general that a potential ground for
- 16 removal exists. If the potential ground for removal involves the
- 17 presiding officer, the executive director shall notify the next
- 18 highest ranking officer of the board, who shall then notify the
- 19 governor and attorney general that a potential ground for removal
- 20 exists.
- Sec. 508.056. EXPENSE REIMBURSEMENT. Each board member is
- 22 entitled to reimbursement for expenses incurred in traveling to and
- 23 from the business of the board at the rates provided in the General
- 24 Appropriations Act for state employees. A member may not receive
- 25 actual or necessary expenses except for travel to and from
- 26 meetings.
- Sec. 508.057. OFFICERS. (a) The governor shall designate a

- 1 member of the board as presiding officer. The presiding officer
- 2 serves in that capacity at the will of the governor.
- 3 (b) The board shall elect an assistant presiding officer to
- 4 serve as provided by board rule.
- 5 Sec. 508.058. MEETINGS. (a) The board shall meet at least
- 6 three times each year.
- 7 (b) The board may hold other regular meetings as provided by
- 8 board rule and special meetings as determined by the board.
- 9 Sec. 508.059. TRAINING. (a) A person who is appointed to
- 10 and qualifies for office as a member of the board may not vote,
- 11 deliberate, or be counted as a member in attendance at a meeting of
- 12 the board until the person completes a training program that
- 13 complies with this section.
- 14 (b) The training program must provide the person with
- 15 information\_regarding:
- 16 (1) the law governing board operations;
- 17 (2) the programs, functions, rules, and budget of the
- 18 board;
- 19 (3) the scope of and limitations on the rulemaking
- 20 authority of the board;
- 21 (4) the types of board rules, interpretations, and
- 22 enforcement actions that may implicate federal antitrust law by
- 23 <u>limiting competition or impacting prices charged by persons engaged</u>
- 24 in a profession or business the board regulates, including any
- 25 <u>rule, interpretation, or enforcement action that:</u>
- 26 (A) regulates the scope of practice of persons in
- 27 a profession or business the board regulates;

1	(B) restricts advertising by persons in a
2	profession or business the board regulates;
3	(C) affects the price of goods or services
4	provided by persons in a profession or business the board
5	regulates; or
6	(D) restricts participation in a profession or
7	business the board regulates;
8	(5) the results of the most recent formal audit of the
9	board;
10	(6) the requirements of:
11	(A) laws relating to open meetings, public
12	information, administrative procedure, and disclosure of conflicts
13	of interest; and
14	(B) other laws applicable to members of the board
15	in performing their duties; and
16	(7) any applicable ethics policies adopted by the
17	board or the Texas Ethics Commission.
18	(c) A person appointed to the board is entitled to
19	reimbursement, as provided by the General Appropriations Act, for
20	the travel expenses incurred in attending the training program
21	regardless of whether the attendance at the program occurs before
22	or after the person qualifies for office.
23	(d) The executive director of the executive council shall
24	create a training manual that includes the information required by
25	Subsection (b). The executive director shall distribute a copy of
26	the training manual annually to each board member. Each member of

the board shall sign and submit to the executive director a

- 1 statement acknowledging that the member received and has reviewed
- 2 the training manual.
- 3 SUBCHAPTER C. GENERAL POWERS AND DUTIES
- 4 Sec. 508.101. GENERAL POWERS AND DUTIES OF EXECUTIVE
- 5 COUNCIL. (a) The executive council shall administer and enforce
- 6 this chapter.
- 7 <u>(b) The executive council may:</u>
- 8 (1) adopt and enforce rules necessary to perform the

- 22 <u>license</u>, including rules limiting an applicant's eligibility for a
- 23 <u>license based on the applicant's criminal history;</u>
- 24 (B) the scope of practice of and standards of
- 25 care and ethical practice for the practice of art therapy; and
- 26 (C) continuing education requirements for
- 27 license holders; and

- 1 (2) a schedule of sanctions for violations of this
- 2 chapter or rules adopted under this chapter.
- 3 Sec. 508.103. ROSTER OF PERSONS LICENSED UNDER THIS
- 4 CHAPTER. The executive council shall compile and publish annually
- 5 <u>a roster of names, license numbers, and addresses of each person</u>
- 6 licensed under this chapter.
- 7 Sec. 508.104. FEES. (a) Subject to Subsection (b), the
- 8 executive council shall establish reasonable and necessary fees for
- 9 the administration of this chapter, including fees for license
- 10 applications and license renewals and any penalty fee for late
- 11 renewals.
- 12 (b) The fee to apply for a professional art therapist
- 13 license must be at least \$183.
- 14 SUBCHAPTER D. LICENSE REQUIREMENTS
- 15 Sec. 508.151. LICENSE REQUIRED TO PRACTICE ART THERAPY;
- 16  $\underline{\text{TITLE RESTRICTIONS.}}$  (a) A person may not engage in the practice of
- 17 art therapy unless the person is licensed under this chapter.
- 18 (b) Unless the person holds the appropriate license under
- 19 this chapter, a person may not use or cause to be used:
- 20 (1) the titles "licensed professional art therapist"
- 21 or "licensed associate art therapist";
- 22 (2) the abbreviations "LPAT" or "LAAT"; or
- 23 (3) any other title, designation, word, letter,
- 24 abbreviation, or insignia indicating the practice of art therapy.
- Sec. 508.152. APPLICATION; ISSUANCE. (a) A person may
- 26 apply for a license under this chapter by submitting an application
- 27 to the executive council and paying any required fee. The

- 1 <u>application must:</u>
- 2 (1) be on a form and submitted in a manner prescribed
- 3 by the executive council;
- 4 (2) include evidence satisfactory to the executive
- 5 council that the applicant meets the eligibility requirements for
- 6 the license for which the applicant is applying; and
- 7 (3) contain any other information required by
- 8 executive council rule.
- 9 (b) The executive council shall review applications
- 10 submitted under Subsection (a) and issue the appropriate license to
- 11 a person who meets the eligibility requirements of this chapter for
- 12 the license for which the person applied.
- Sec. 508.153. ELIGIBILITY FOR PROFESSIONAL ART THERAPIST
- 14 LICENSE. (a) To be eligible for a professional art therapist
- 15 license, an applicant must:
- 16 (1) be at least 21 years of age;
- 17 (2) be licensed as an associate art therapist;
- 18 (3) subject to Subsection (b), have completed the
- 19 minimum number of hours practicing art therapy as a licensed
- 20 associate art therapist as required by executive council rule in a
- 21 period of not less than two years, which may not be less than 3,000
- 22 hours; and
- 23 (4) satisfactorily complete the Art Therapy
- 24 Credentials Board Examination (ATC-BE) or a substantially similar
- 25 examination approved by the executive council.
- 26 (b) With respect to the hours required under Subsection
- 27 (a)(3):

1	(1) at least 1,500 of those hours must have been spent
2	practicing art therapy with clients in face-to-face meetings for
3	the purpose of diagnosing or treating mental, emotional,
4	behavioral, or addiction disorders;
5	(2) for every 10 hours the licensed associate art

7	meetings, the qualified art therapy supervisor must provide to the
8	licensed associate art therapist at least one hour of direct
9	supervision by face-to-face meeting; and
10	(3) notwithstanding Subdivision (2), the qualified
11	art therapy supervisor must provide at least two hours of
12	supervision each month to the associate art therapist through group
13	or individual supervision, which shall be credited toward meeting
14	the hours of supervision required by Subdivision (2).
15	Sec. 508.154. ELIGIBILITY FOR ASSOCIATE ART THERAPIST
16	LICENSE. To be eligible for an associate art therapist license, an
17	applicant must:
18	(1) be at least 21 years of age;
19	(2) either:
20	(A) have completed a master's or doctoral degree
21	program in art therapy with an accredited educational institution
22	that included at least 700 hours of supervised educational
23	experience through an internship; or
24	(B) have completed each of the following:
25	(i) a master's or doctoral degree program in
26	a field related to art therapy with an accredited educational
27	institution;

- 4 DURING ART THERAPY SERVICES. (a) Any communication made between a
- 5 licensed professional art therapist or a licensed associate art
- 6 therapist and the therapist's client while the therapist is
- 7 practicing art therapy is confidential.
- 8 (b) A communication that is confidential under this section
- 9 may not be disclosed by the therapist unless:
