- SECTION 2. Subchapter F, Chapter 11, Water Code, is amended
- 2 by adding Section 11.2011 to read as follows:
- 3 Sec. 11.2011. APPLICABILITY. This subchapter, other than
- 4 Sections 11.202(c) and 11.206, applies only to an artesian well
- 5 drilled outside the boundaries of a groundwater conservation
- 6 district, subsidence district, or other conservation and
- 7 reclamation district with the authority to regulate the drilling,
- 8 spacing, or production of water wells.
- 9 SECTION 3. The following provisions of the Water Code are
- 10 repealed:
- 11 (1) Sections 11.202(d) and (e);
- 12 (2) Section 11.203;
- 13 (3) Section 11.204; and
- 14 (4) Section 11.207.
- 15 SECTION 4. This Act takes effect immediately if it receives
- 16 a vote of two-thirds of all the members elected to each house, as
