Section 241.023, Health and Safety Code, is amended by amending Subsections (c-1) and (c-2) and adding 6 Subsection (h) to read as follows: 7 8 (c-1) The department may issue: (1) one license for multiple hospitals if: 9 (A) [(1)] all buildings in which inpatients 10 receive hospital services and inpatient services of each of the 11 hospitals to be included in the license are subject to the control 12 and direction of the same governing body; 13 14 (B) [(2)] all buildings in which inpatients receive hospital services are within a 30-mile radius of the main 15 16 address of the applicant; (C) [(3)] there is integration of the organized 17 18 medical staff of each of the hospitals to be included in the 19 license; 20 (D) [(4)] there is a single chief executive 21 officer for all of the hospitals who reports directly to the governing body and through whom all administrative authority flows 22 and who exercises control and surveillance over all administrative 23 activities of the hospital; 24

1 (E) [(5)] there is a single chief medical officer 2 for all of the hospitals who reports directly to the governing body 3 and who is responsible for all medical staff activities of the 4 hospital;

5 <u>(F)</u> [(6)] each building of a hospital to be 6 included in the license that is geographically separate from other 7 buildings of the same hospital contains at least one nursing unit 8 for inpatients, unless providing only diagnostic or laboratory 9 services, or a combination of diagnostic or laboratory services, in 10 the building for hospital inpatients; and

11 (G) [(7)] each hospital that is to be included in 12 the license complies with the emergency services standards: 13 (i) [(A)] for a general hospital, if the

14 hospital provides surgery or obstetrical care or both; or 15 (ii) [(B)] for a special hospital, if the

16 hospital does not provide surgery or obstetrical care; and 17 (2) one license for a hospital and a mobile stroke unit

18 <u>of the hospital if the mobile stroke unit is accredited by a health</u> 19 <u>care accreditation organization approved by the Centers for</u> 20 Medicare and Medicaid Services.

21 (c-2) The department may recommend a waiver of the 22 requirement of Subsection (c-1)(1)(G) [(c-1)(7)] for a hospital if 23 another hospital that is to be included in the license:

24 (1) complies with the emergency services standards for25 a general hospital; and

(2) is in close geographic proximity to the hospital.
(h) Subsection (g) does not apply to a license issued to a

1 mobile stroke unit of a hospital under Subsection (c-1)(2).

2 SECTION 2. As soon as practicable after the effective date 3 of this Act, the executive commissioner of the Health and Human 4 Services Commission shall adopt rules necessary to implement 5 Section 241.023(c-1), Health and Safety Code, as amended by this 6 Act.

7 SECTION 3. This Act takes effect September 1, 2025.
