- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF TEXAS:
- 5 SECTION 1. Section 7951A.0106, Special District Local Laws
- 6 Code, is amended to read as follows:
- 7 Sec. 7951A.0106. [INITIAL] DISTRICT TERRITORY. (a) The
- 8 district is [initially] composed of the territory described by
- 9 Section 2A $[\frac{2}{3}]$ of the Act enacting this chapter.
- 10 (b) The boundaries and field notes contained in Section 2A
- 11 $[\frac{2}{2}]$ of the Act enacting this chapter form a closure. A mistake made
- 12 in the field notes or in copying the field notes in the legislative
- 13 process does not affect the district's:

- 15 (2) right to issue any type of bond for the purposes
- 16 for which the district is created or to pay the principal of and
- 17 interest on a bond;
