Sections 508.141(g) and (g-1), Government Code, are amended to read as follows: 6 7 (g) The board shall adopt a policy establishing the date on which the board may reconsider for release an inmate who has 8 previously been denied release. The policy must require the board 9 to reconsider the inmate for release [+ 10 11 [(1) an inmate serving a sentence for an offense 12 listed in Section 508.149(a) or for an offense punishable as a felony of the second or third degree under Section 22.04, Penal 13 Code, during a month designated under Subsection (g-1) by the 14 parole panel that denied release [; and 15 [(2) an inmate other than an inmate described by 16 Subdivision (1) as soon as practicable after the first anniversary 17 of the date of the denial]. 18 (g-1) The month designated for reconsideration [under 19 20 Subsection (g)(1) by the parole panel that denied release] must: 21 (1) except as provided by Subdivision (2), begin after the first anniversary of the date of the denial and end before the 22 23 fifth anniversary of the date of the denial; or 24 (2) if [, unless] the inmate is serving a sentence for

1 an offense under Section 22.021, Penal Code, or a life sentence for 2 a capital felony, [in which event the designated month must] begin 3 after the first anniversary of the date of the denial and end before 4 the 10th anniversary of the date of the denial.

5 SECTION 2. The Board of Pardons and Paroles shall adopt a 6 policy consistent with Section 508.141, Government Code, as amended 7 by this Act, as soon as practicable after the effective date of this 8 Act.
